



The Sons of Camp 17 and Daughters of Tent 88 have joined forces with the Santa Ana-Tustin-Orange Tri-City Veterans and Service Organizations to help sponsor and organize the Memorial Day observance at Santa Ana Cemetery. Veterans of the American Legion and VFW Posts of the three cities along with Elks BPO, Emblem Club, and Lions Club are taking lead roles in the organization and presentation of the ceremony. Our southern cousins in the Sons of Confederate Veterans are also participating in both the planning and performance of the observance.

As in past years the ceremony will start at 10:00 AM at the GAR plot near the Santa Clara Avenue entrance to the

cemetery. Musical tributes will be provided by the band and chorus of Orange High School along with martial aires performed by Civil War era fifer-drummer Stephen Schmitt who is a longtime friend of the SUVCW. The color guard/honor guard of VFW District 2 and the Orange Post will provide a rifle salute, and Civil War re-enactors of Battery B-1<sup>st</sup> Pennsylvania Light Artillery (Cooper's Battery) will fire a cannon salute. The Orange Emblem Club will perform the flag folding ceremony, and all participating organizations will present their colors and a wreath to be lain at the Monument to the Unknown Dead in the GAR Plot.

The honored guests this year will be Congressman Ed Royce and County Supervisor Janet Nguyen. The Santa Ana VFW Boy Scout of the Year will lead the Pledge of Allegiance, and VFW Voice of Democracy winner Lindsey Ungerman of Canyon High School will read from her award winning essay. The keynote speaker will be Vietnam veteran Marine and Army Ranger William S. Ungerman. A special award of appreciation will be presented to Florence Leach of the Women Marines Association who has been the chair-person and organizer of the Memorial Day ceremony for the past several years.

The Orange County Cemetery District and Santa Ana Cemetery are providing gravesite flags for the over 650 veterans' graves at the cemetery, and Boy and Girl Scouts from the Orange County Council accompanied by volunteers will place the flags at the gravesites starting at 9:00 AM on Saturday, May 24.

Decoration Day or Memorial Day ceremonies have been observed at the cemetery from as early as 1882 when Grand Army of the Republic veterans from Sedgwick Post No. 17 held services there and decorated the graves of their five Civil War comrades who were interred there at the time. After that observance on May 30, 1882 the veterans and their entourage of Santa Ana citizens traveled on to Anaheim Cemetery where they performed a similar observance.

A Memorial Day ceremony will also be performed at nearby Fairhaven Memorial Park starting at 10:30 AM on Monday, May 26, 2008. Tent 88 namesake Elizabeth Hill-Mills is entombed at Fairhaven Park.

Kuhn Jr. has issued his General Order #17 reminding us of our obligation to this Historic Holiday. I follow that tradition, and as fate would have it, this my Department Order #11.

As it is our First Fraternal Obligation to keep and observe Memorial Day, and every Camp should have at least one Memorial Day event scheduled, Let us do all we can to have every brother participate in a Service of Memorial. Please send the attached letter to every Brother, either by mail or electronically.

As few fraternal organizations have ever created a National Holiday, it is truly our duty to carry this on, so that future generations know it well.

The foregoing Department Order is proclaimed this 5th day of May in the year of our Lord two thousand eight, and of the Independence of the United States of America the two hundred thirty-second, in the Town of Fallbrook, County of San Diego, State of California by Jerry R. Sayre, Commander of the Department of California and Pacific, Sons of Union Veterans of the Civil War.

# Sedgwick-Granger Camp 17 Sons of Union Veterans of the Civil War Tustin, CA Minutes of Meeting – March 27, 2008

The meeting was opened by Commander Gillette at 7:10 pm. Walter Davis opened the Bible and gave the invocation. Patriotic Chairman, Jim Blauer, led the Pledge of Allegiance. Secretary Charles Beal took the roll. Those in attendance included; Danny Cox, Charles Beal, Jim Blauer, Walter Davis, Floyd Farrar, Glen Roosevelt, Don Hoffer, Robin Bowers, Joe Hart, John Heckman, Marcus Deemer, and Paul Gillette.

Guests included Susan Sweet, Carol Collcott, Kelly, Maureen and Darrell Rivers.

The Treasurer's Report was given by Charles Beal. As of January 17 we had \$1,055.82. We had income of \$2,813.32 and expenses totaled \$1,354.48. This gave a balance of \$1,458.84. It was moved by Joe Hart and seconded by John Heckman, subject to audit, that this report be approved. The motion passed.

IRS Form 990-N was electronically filed by Charles Beal & Glen Roosevelt on 2/4/08. This new procedure is for non-profit organizations with less than \$25,000 in their account.

Walter Davis reported he has a spot on his kidney that he will know the results about next week. Jim Blauer is recovering from this elbow infection.

There are two applications before us this evening: Darrell Rivers and Scott Hansen. Darrell's 4<sup>th</sup> great grandfather, Pvt. John Gannon, was in Company E of the 17<sup>th</sup> MA Infantry. Scott's 3<sup>rd</sup> great grandfather, Pvt. Nathan S. Young, was in Company M of the 17<sup>th</sup> PA Cavalry. It was moved by Walter Davis that these men be admitted to the Camp and was seconded by Joe Hart. The motion carried and their applications were accepted. Note: Darrell's Eagle Scout Court of Honor is this Sunday-Congratulations!

The Minutes from 1-17-08 having been passed out, Joe Hart moved that we accept them as printed in the Newsletter. This was seconded and the motion passed.

Commander Gillette read Department Order 2. The following Brothers are appointed to the Department Exploratory Committee for Possible Hosting of National Encampment: Glen Roosevelt PCC (Chairman), Brad Schall PDC, and any others the Chairman deems necessary. Patriot Hall will not be completely refurbished by 2012. Glen Roosevelt reported that they are looking for other sites in the Southern California area to meet the criteria set by National SUVCW.

Tom Chumley (Camp 2) has invited other camp members to attend the dedication of 2 unmarked Union graves at Lancaster Cemetery, 111 E. Lancaster Blvd in Lancaster in the City of Lancaster on April 12<sup>th</sup> at 2:00 pm. See Commander Gillette or JVC Roosevelt will provide further details.

Glen Roosevelt reported upcoming events at Prado Regional Park on April 5-6; St. Catherine's Military Academy (Anaheim) on April 19-20; El Dorado Park (Long Beach) the weekend after Memorial Day.

Floyd Farrar reported that there is movement sponsored by the SUVCW to put Memorial Day back to May 30.
