#### Grave Marker Installed at Loma Vista Memorial Park - Fullerton

Graves Registration Officer Charles Beal has reported that a grave marker has been installed for Henry A. Dawson in Loma Vista Memorial Park in Fullerton. Dawson was born in England in 1841. He served in Company K of the 1st U.S. Artillery and Company A of the 2nd U.S. Artillery. After the war he lived in California for 20 years, the last 14 years in the City of Brea. He was a member of the Malvern Hill GAR Post #131 in Fullerton. He died September 8, 1928 and was interred at Loma Vista Memorial Park in Fullerton. The Civil War Monument was provided by the V. A., and it was installed at his gravesite in January 2009.



#### **Corona Genealogical Researchers Shed Light on Carleton GAR Post # 168**

I have made contact through the Corona Genealogical Society; and by Paul Gillette with two ladies of the local DAR, Diane Wright and Kathleen Dever. They have been doing research on Sunnyslope Cemetery in Corona. They have located at least 5 graves of Civil War soldiers. Currently, all the graves have headstones for those they have located. They are interested to find whether there is any marker or badge that could attached to indicate GAR or Civil War service. They are putting on an annual cemetery walk on Sunday, October 25; and they are looking for a small number of reenactors to do first person roles of those they have identified, similar to Paul Gillette's talk at Magnolia each year.

The SUVCW GAR Post Project database shows a Carleton Post No. 168 in South Riverside, the original name for the town of Corona. The Carleton Post was organized there in 1893. The researchers already have a roster for Post #168 from the Corona library. There are also some other Post # 168 artifacts in the Library collection. A monument near the entrance to the cemetery recognizes the "Fallen Heroes" of the Civil War, Spanish American War, WW1, WW2, Korea, and Vietnam. The inscriptions for the Korean and Vietnam eras were obviously added to the monument at a later time, but we don't know yet if the original monument was dedicated only to the Civil War veterans. One of the burials is that of Captain John L. Merriam of the 1st California Cavalry who served under General Carleton in Arizona Territory in 1864. It appears from newspaper reports that Captain Merriam was prominent in organizing the veterans for Decoration Day services in 1893, and perhaps he was one of the founders of the GAR Post. Mrs. Anna B. Merriam is buried next to her husband, and her grave is also marked with a Government marker like Captain Merriam's.

# Sedgwick-Granger Camp 17 Sons of Union Veterans of the Civil War Minutes of Meeting – January 15, 2009 Tustin, CA

The meeting was opened by Commander Paul Gillette at 7:05pm. Chaplain Dan Henry opened the Bible and gave the invocation. Patriotic Instructor Jim Blauer led the Pledge of Allegiance. Secretary Charles Beal called the roll. Those in attendance included: Charles Beal, Jim Blauer, Robin Bowers, Danny Cox, Walter Davis, Martin Deemer, Bob Drennan, Floyd Farrar, Paul Gillette, Joe Hart, Dan Henry, Don Hoffer, Richard Ignatius, Greg Lutes, Bill Nelson, Glen Roosevelt, and Terry Shaw. It was reported that we have 63 current members. Guests in attendance included; Janet Uribe (DUV meeting), Department Secretary Phil Caines and his wife Melinie of the ASUVCW, and Department Commander Jerry Sayre and his wife Kim.

At this point Commander Paul Gillette turned the proceedings over to Department Commander Jerry Sayre for the purpose of installing the officers for 2009. Following the installation (swearing in) of the Camp officers, Floyd Farrar was installed and presented with the gavel. Both Floyd and Paul were presented medals. Glen thanked Paul for his leadership as Commander. He had stepped in when Mark Wolfington was transferred to Illinois. Glen then thanked all the members for keeping the Camp going. We started with 19 members 5 years ago and now have 63 members. Camp 17 is one of the largest camps in the order.

The Walter Davis Award was presented to Glen Roosevelt. Glen is the second recipient of this Award. Charles Beal received it the first year it was awarded.

Walter Davis moved that the minutes as written in the newsletter be accepted as printed. This was seconded by Charles Beal. The motion passed.

The Treasurer Reported that as of November 20 we had \$1,678.86. Total expenses were \$25.00. As of this meeting we have \$1,653.86. This does not include any dues collected. Walter Davis moved that we accept the treasurer's report subject to audit. Dan Henry seconded the motion and the motion passed.

Terry Shaw reported that John Heckman's wife was in the hospital.

There were no new applications, no new members to present certificates to, no bills, and no unfinished business.

Under new business events were noted. These included; 1) The ACWS reenactment in March next year, 2) Camp 21 Bicentennial Celebration of Abraham Lincoln's birth, February 12-14 Balboa Park next to the Navy Chapel, 3) The American Legion will have a celebration on Friday the 13 of February for Abe's birthday, 4) on Feb 19 there will be a ceremony at the Santa Ana Civic Center for new Medal of Honor recipient (posthumous) Michael Monsoor of Garden Grove. It is at 11am. All are invited to attend. 5) On February 21 the Huntington Library in San Marino will have an exhibition on Lincoln materials. The event will include a brass band. 6) On February 14-15 there will be a School for Soldiers at Knott's Berry Farm. 7) On March 6-7 the Department Encampment will take place at Camp San Luis Obispo in the NCO Club. 8) Glen noted the web links to these items in the newsletter. He noted we are committed to St. Catherine's Military Academy, but have no commitment with the Knott's Berry Farm event.

For the Good of the Order Phil Caines reported that he advised Camp 2 to look into a bus trip in April. The trip will start at Long Beach from the Lincoln Statue, go to the Drum Barracks, to the Lincoln Shrine in Redlands and return to Long Beach. This is to be planned for a Saturday. It is possible that at that time Camp 2 and the City of Riverside will present its Citizen of the Year Award Camp 2 member Gen. Wright.

Richard Ignatius noted there was a book of a Civil War Ancestor who wrote home every three days. Bob Drennan showed an original Cap and told of a mini-ball found in one of the fence rails at Gettysburg. Paul Gillette showed an 1864 Cavalry Saber in good condition. Sabers are curved and swords are straight. He also showed a canon ball he got for \$7.00 from a farmer whose land was a part of a battle field. Glen Roosevelt showed some books on his ancestors and family, particularly on Wisconsin regiments where his ancestor was from. Danny Cox told of his grandfather who told great stories and related one to us. Terry Shaw handed out copies of the Bill of Fare at Lincoln's second inauguration that had been printed in the L.A. Times.

It was noted that dues were due and they are \$35.00.

We need delegates to the Encampment. As such expenses are tax deductible. Each Camp can have 1/5th its members as delegates. With 63 members we can have 12 delegates. It was reported that Glen and Floyd planned to attend. Walter Davis moved that all those going would be designated as delegates. This was seconded by Dan Henry and passed.

At the direction of Commander Floyd Farrar, Chaplain Dan Henry closed the Bible and gave the benediction.

The meeting was adjourned at 8:05pm
