A National Per Capita dues increase of \$5.00 was approved by the National Encampment on August 13. This increase will take affect for the Camp dues which are collected and submitted to National at the beginning of 2011. A discussion about raising the Camp membership dues by \$5.00 to offset the National increase will be debated at the November meeting. "Doc" served as a Navy Corpsman during 1970-1971 with the Marines in Vietnam in the 2nd Combined Action Group, 4th Combined Action Company, Combined Action Platoons 2-4-3, 2-4-2, 2-4-1 and 2-4-6 in Quan Hieu Nohn/Quan Dien Ban Districts, I Corps. "Doc" was wounded on 25 April 1970.



#### Camp 17 Terry Shaw & Family Celebrate Daughter's Navy Boot Camp Graduation

In the spring of 2005 I came across a youth program I thought would benefit my son, Thomas, called U.S. Naval Sea Cadet Corps. This is structured along the lines of the US Navy with meetings during the month and one and two week trainings during school breaks on military bases including a boot camp. Turns out our daughter, Christina, was interested in it more than Thomas, who stayed involved two years. Fast forward four years and Christina came out as a Petty Officer First Class, just below Chief Petty Officer, the highest rank attainable in Sea Cadets. After graduating high school and working part time for a year on a "party" boat in Newport Harbor she decided to make the big commitment and joined the Navy in mid July of this year and it was off to Great Lakes Naval Training Station, IL. During boot camp, Christina was selected by her peers as Honor Recruit for her division consisting of 80 recruits. She also served as AROC, second recruit n charge and the one that calls cadence.

Graduation/Pass in Review was Sept. 10 and her boyfriend, Dima, mother Marilyn and I were there. During the impressive ceremony, honor recruits from all 10 divisions and special award recipients are recognized as well as being invited to a special reception afterwards where we got to shake hands with all the "brass". Due to her participation and achievements in Sea Cadets, Christina also came out of boot camp with an extra stripe, pay grade E3 instead of E2. After boot camp she moved "across the street" for A (apprentice)-school in her assigned job, Engineman, learning to work on diesel engines and myriad other tasks. She is scheduled to complete this in mid November and will then be assigned a duty station.

Having never been to the Midwest, I decided on three pronged attack for our trip. The genesis for the trip, of course, was Christina's graduation. After that we made a day trip to Chicago. Then it was time for phase two, on to Winona and Rochester MN where I researched family "roots" on my mother's side. Phase three meant going back to Kenosha WI to visit friends (the husband is a transplant from CA) who showed us the state capital building in Madison, lighthouses and Milwaukee, where we took a boat cruise. My friend and I also took in the Civil War Museum in Kenosha. Mission accomplished, it was time to head home.

#### Minutes of the Meeting of Sept. 16, 2010

The meeting was held in the Fellowship Hall, First Advent Christian Church, 555 W. Main St. (corner of Main & Pacific), Tustin, CA

The meeting was called to order at 7:05 pm by Commander Farrar.

The prayer was given by Walter Davis acting as Chaplain. The Pledge of Allegiance and Flag Salute was led by JVC Charles Beal.

The Brothers present were: Floyd Farrar, Charles Beal, Glen Roosevelt, Don Hoffer, Walter Davis, Bob Drennan, Jim Fosdyck and Joe Hart.

Commander Farrar read General Order #3 dated September 1, 2010 concerning the passing of a Real Son, Brother Arthur Clark of Chaplin Camp #3 in Bangor, Maine. The Camp Charter had been draped in the memory of Brother Clark.

A motion to approve the minutes of the May 20, 2010 meeting was made by Brother Davis and seconded by Brother Roosevelt. Motion was passed.

Treasurer's report was given by Glen Roosevelt as Treasurer Terry Shaw was out of town. The previous balance was \$3,500.61. Current balance was \$2,247.61. Brother Roosevelt pointed out a concern he found in the current balance at 9/16/2010 versus the balance of \$2,865.61 at 3/1/2010 that needs to be reviewed. Motion to approve, subject to audit was made by Brother Davis and seconded by Brother Hart. Motion was passed. Editor's note: The approximately \$600 difference was caused by collected dues sitting in the 3/1/2010 balance that were not paid out to National and Department until June. Without a meeting in July, the large decrease in the balance did not become evident until the September report. PCC Roosevelt believes there is no reason for concern, the balance appears to be correct.

Report on sick/distressed brothers: Jim Fosdyck is recovering from bladder surgery that was performed in June. Joe Hart received 45 stitches in his hand from an sawing accident. Brother Robert Harris was recently reported as having passed away on October 13, 2009. See article in the Jun.-Sep. Camp newsletter, page 10.

One new Junior membership was presented for Robert Richardson of Visalia, CA. His 3<sup>rd</sup> great grandfather, Jacob Bechtel served in 59<sup>th</sup> New York Infantry. Motion to approve was made by Brother Davis and seconded by Brother Drennan. Motion was passed.

No old business was reported.

New Business:

Brother Fosdyck reported that Brother Lutes was awarded by the SAR, the wounded warrior certificate last May.

A new Camp in the Inland Empire was being founded. Camp #18, General George Stoneman is forming in Riverside. See article in Jun.-Sep. Camp newsletter, page 11.

Commander Farrar has been working with Margaret Alley to help located Civil War graves at Downey and Artesia cemeteries in Los Angeles County.

Remembrance Day (November 20) activities will be held at Drum Barracks Civil War Museum. See article in Jun.-Sep. Camp newsletter, page 6.

Brother Roosevelt talked about raising the National dues by \$5.00 as approved by the National Encampment. This item about raising the membership dues by \$5.00 will be debated at the November meeting.
