National Encampment Stipulates New Reporting Deadlines

The 2011 National Encampment created the following new requirements for reporting the Installation of Camp Officers: a) The Installing Officer shall complete the Installing Officer's Report (Form 22) before departing and provide the same to the Camp Secretary to be filed with the Department Secretary. b) The Camp Secretary shall forward to the Department Secretary the Installing Officer's Report (Form 22) on or before February 15th of each calendar year. c) The Department Secretary shall compile a report consisting of the Entity Identification Number (EIN) and IRS contact person (name, address, telephone number and e-mail address if any) for each camp. The report shall be provided to the National Treasurer on or before March 15th of each calendar year. New member reporting was also updated, stipulating that, "...the application ...shall be forwarded to the Department Treasurer with the Camp Status Report (Form 30) by the 15th day of the month following receipt of the application". Please help our Camp Secretary meet these and other requirements by reenlisting for next year, and getting your dues payments in by January 15, 2012.

#### Camp 10 SUVCW Sesquicentennial Signature Event in Monterey


Abe Lincoln Camp 10 hosted the 5<sup>th</sup> annual Fort Mervine "Civil War Encampment," a Civil War Sesquicentennial Signature event, held October 8<sup>th</sup> & 9<sup>th</sup>, in Monterey, CA. The event included participants from Rosecrans Camp 2, Sheridan Camp 4, Lincoln Camp 10, Sedgwick-Granger Camp 17, Pittenger Camp 21, Wright Camp 22, Ellsworth Camp 23, and Pleasonton Camp 24, as well as Sisters from Rosecrans Auxiliary 2, Stiers Auxiliary 23, and Dr. Walker Auxiliary 52. The event observed the 150<sup>th</sup> anniversary of recruiting and forming Company K of the 5<sup>th</sup> California Volunteer Infantry in Santa Cruz and Monterey.

Twice-daily firing demonstrations, featuring a six musket and one pistol firing detail by members of the 6<sup>th</sup> MD's Co. C, 8<sup>th</sup> CA. Inf. and Co. G, 5<sup>th</sup> CA. Inf., SVR. The *California Historical Artillery Society* (CHAS) fired a Civil War cannon, as well and had a horse team towing a Civil War Ambulance. The Department provided nine tent displays of various themes. The encampment was directed by DSVC Tim P. Reese.

Fort Mervine was designed by Lt. Henry Halleck in 1846, with construction supervised by Lt. Edward O.C. Ord, and second in command Lt Wm. T. Sherman. In February 1865, during the last months of the Civil War, Co. B, 2<sup>nd</sup> U.S. Artillery; Co G, 6<sup>th</sup> CA Inf.; and Co. B, 1<sup>st</sup> CA Native Cavalry were stationed there.

## \* Author Discusses His Civil War Book at September Meeting

David Edward Wall discussed his book Always In The Middle Of The Battle: Edward Kiniry And The 1st

*Illinois Light Artillery Battery D* at the September Camp meeting.

The book describes Wall's grandfather, Edward Kiniry, a young Illinois private, who served in Battery D, 1st Illinois Light Artillery, from 1861-1864. His letters, as well as a unit history of the battery, are smoothly mixed with the comments of the soldier's grandson and the author of this book. Mr. Wall visited many of the sites where his grandfather fought in the Western Theater, and wrote of the intensity of his feelings when standing on the very ground where the battery had been positioned. In addition, his research was thorough and well documented. The book is available on-line at Amazon.com, and other sellers.

## \* SVC Charles Beal Auditions for *America's National Treasures*

America's National Treasures, a new television series from the National Geographic Channel, came to Santa Ana on Monday, November 14; and our own Camp SVC Charles Beal was there to greet them. The series is something of a cross between Antiques Road Show and the History Detectives. They are searching for objects which may be of historic interest which their experts will evaluate in consultation with other experts in the field. The film crew is going to other places in the U.S., and then they will air the shows in late spring or early summer next year.

Monday was a very long day for Charles who was at Bowers Museum for 10 hours! He was the next to last to be interviewed, and left there around 7:00 pm. Charles did a lot of standing and talking in small groups all day to be in the background while other persons were being interviewed. He brought the panoramic photograph of the 1919 GAR Department Encampment in Santa Ana, along with his associated collection of ribbons and badges from the Encampment. The photograph and ribbons were pretty popular along with the others in attendance. His collection was one of the few local items brought in. Charles had a great time talking to everyone and hearing stories about their treasures. A couple of other people brought in Civil War memorabilia. One had a diary from a soldier in Louisiana during 1864-1865, and another had an 1841 pistol.

Unfortunately, our treasure hunter did not make the show's first cut, and he was not called back for a second interview. The show did provide him with a lengthy written response and evaluation of the photograph and ribbon collection.

The Camp will receive a special encore presentation at the Thursday meeting when Charles brings the 1919 photograph and ribbon collection to our Camp meeting.
