The 126th Annual Encampment of the Department of California and Pacific was held at the NCO Club of Camp San Luis Obispo on Friday March 9 and Saturday March 10, 2012. Camp 17 provided its largest delegation ever as it was represented by Camp Commander Charles Beal, SVC Joe Hart, Secretary-Treasurer Terry Shaw, and PCC Glen Roosevelt. Camp 17 Commander Beal gave the Camp Annual Report, and





presented a check for \$600 towards the 2012 National Encampment Fund as a consolidated donation by the Camp and its members.

National C-in-C Donald Palmer was the guest of honor of the Encampment. The Encampment proceedings included a Friday evening social "campfire" and dinner, the Saturday business meeting, a luncheon, a memorial service at the San Luis Cemetery, and a Saturday evening dinner with the C-in-C. Delegates to the National Encampment coming up in August were appointed that filled our entire Department quota. over \$7,000 has been accounted for in donations and pledges towards the hosting fund for the 2012 National Encampment in Los Angeles. The Department created the Annual Kirby R. Morgan Award for preservation of Civil War and GAR memorials by a non-Allied Orders member (civilian) in honor of long-time Civil War Memorials Officer, Kirby Morgan. Camp 17 PCC Roosevelt presented a \$300 check to newly chartered Camp 18 on behalf of the Camp 17 Brothers to help the new Camp start-up fund.



Besides conducting their own business, the Sisters of the Department Auxiliary performed most of the setup of the administration stations, helped with badges, set out the raffle displays, and conducted the door prize awards and silent auction in support of the Department. Great thanks are extended to all the ladies of the Auxiliary for their outstanding efforts. The Auxiliary also presented a donation of \$500 to the 2012 National Encampment Fund.

The most thankless job of the Encampment that actually is due the most thanks was again that of our Secretary-Treasurer Phil Caines. He handled all the registration, credentials, administration, records-keeping, financial reporting, and minutes-taking from the confines of his traveling office of computers, copiers, and boxes of records without a complaint. We also pass on kudos to the NCO Club management and Phoenix Catering for providing an outstanding venue and great food service.

### COMMANDER'S CORNER Santa Ana Cemetery GAR Monument Vandalized

I have some sad news to report to our Camp members. The Orange County Cemetery District notified me a couple of weeks ago telling me that the Soldiers' Monument at Santa Ana Cemetery had been vandalized. Vandals tried to dislodge the Eagle from the top of the Monument. The Eagle is still mounted, but there is damage that will need to be repaired after Memorial Day. The Soldiers' Monument was dedicated on Memorial Day, 1915, which was the 50th anniversary of the end of the Civil War.

On Saturday 4/28/12 sometime between 10:30 -11:15, two men were seen vandalizing the GAR Eagle monument. Our security guard was flagged down around 11:10 by a family informing him that two men were hitting the eagle with sticks, causing damage to it. The two men were seen fleeing the scene in a Silver Ford F250, unfortunately they were not apprehended and did not get the license plate of the truck. Julio Amarillas received a call on Saturday. A report from the security company was provided, however the company did not call police to report it. Julio reported it this morning to the SA Police Department. We will probably just need to touch it up prior to Memorial Day, but then work on a permanent solution to restore it. The District is in the process of adding security cameras to the cemetery.

I invite all of our members and guests who are able to attend the upcoming SUVCW meeting this Thursday evening, May 17th at 7:00 pm. We will discuss upcoming Memorial Day activities and the SUVCW National Encampment that is coming to Los Angeles in August.

## Camp 2, 18 & 17 Brothers Help Honor Our Presidents

Brothers from Camp 2, Camp 18, and Camp 17 helped honor President Lincoln and President Washington in two separate ceremonies during the early weeks of February.

Camp 2/18 Brother Ken Walker, Camp 18 PDC Rudy Velasco, Camp 17 Brother Michael Hicks, and Department Commander Glen Roosevelt marched with a SVR Color Guard in the  $73^{rd}$  Annual Redlands Lincoln Pilgrimage on February 4. Brothers Walker, Velasco, and Roosevelt represented the SVR Marine Corps Guard Company – Mare Island; and Brother Hicks represented Co. G,  $5^{th}$  California Infantry – SVR. Camp 18 PDC Velasco proudly unfurled the new Camp flag for the first time in a parade. Also marching as an escort to

President Lincoln (as portrayed by Don Ancel) was Camp 18 Brother Larry Duncan in uniform as a Captain Aide-de-Camp. The Color Guard marched as the second unit of the parade right behind the consolidated Boy Scout flag-bearers. The event is sponsored by the Inland Empire Council of the BSA, and brings together several hundred Scouters to help honor our 16<sup>th</sup> President.

The mile and a half long parade ended at the Redlands Bowl across the street from the Lincoln Shrine. The SVR Color Guard escorted President Lincoln and his wife Mary (portrayed by Jane De Beaumont of Victorville) to the stage of the Bowl where the President gave a well-received talk on the importance of early education to the hundreds of young audience members. After the assembly presentation Brother Walker served as a "questions and answers" sentinel outside the Lincoln Shrine, while Brother Hicks assumed his duties as a docent inside the Shrine. Camp 18 Brother Larry Duncan stepped into his character of Doctor Malarkey, Civil War Surgeon, and he put on his usual outstanding display of "nearly painless medicine" for all the Scouts.

Two weeks later on February 19 the SVR Marines landed again, this time at the **30<sup>th</sup> Annual Massing** of Colors & Salute to Our Armed Forces at Forest Lawn Memorial Park in Hollywood Hills. This event is also dominated by youth as 27 JROTC Color Guards from Los Angeles area high schools participated. The Marine Guard Company was once again represented by Brothers Ken Walker and Glen Roosevelt who presented the SUVCW Department Flag along with the Company's replica USMC National Color. The salute to General & President George Washington is sponsored by The Sons of Liberty Chapter of the SAR.

Also participating in the Massing of Colors were
