Recently the OCCD put me in touch with a descendant of a Confederate Civil War Veteran buried at Santa Ana Cemetery in an unmarked grave. With the help of Margaret Alley (DCV) we are assisting this descendant to honor his Civil War ancestor who died here while visiting in Santa Ana in June 1905.

The SAR will be laying wreaths at the foot of the Veterans Monument at 9am PST. Hundreds of ceremonies will be occurring simultaneously across the country. We would love to have you participate with us in honoring the memory of our veterans. The Orange County Chapter SAR Lee's Legion Color Guard will be presenting the colors and also sponsoring a wreath. Other color/honor guard units are welcome and encouraged to participate. The ceremony will include presenting the colors, invocation, Pledge of Allegiance, the National Anthem, and a few words spoken by a dignitary. Wreaths will then be presented by each group at the foot of the veterans' memorial. Please be encouraged to wear military uniforms and society attire with decorations, if possible. ### Camp 2 SUVCW Sesquicentennial Signature Event Civil War in California – September 1862 Drum Barracks Anniversary Day & Museum Birthday USMC Guard Co.-SVR Naval Landing Party Display

A combined Camp effort of Camps 2, 17, 18, and 21 helped to make the Camp 2 and Auxiliary Sesquicentennial Signature Event at Drum Barracks Civil War Museum a hit on September 22, 2012. The event was developed and coordinated by Camp 2 Commander Loran Bures and Auxiliary No. 2 along with the Drum Barracks Museum staff. The event featured many activities, programs, demonstrations and information focusing on California's participation in the Civil War of that era. Blacksmith Ken Kurtz returned and hammered out some impressive hardware. A special display of California memorabilia was provided by Michael Sorenson and Earl Robinson. Milliners from the Rosecrans Auxiliary provided hat making information and material, and allowed young ladies to make their own hat for a small fee. Camp 2 Commander Bures assisted with locating visitor's surnames in genealogical sites on his computer to find out about their own Civil War history.

SVR members from Camps 2, 17, 18, and 21 represented the Army, Navy and Marines to explain their participation in the California events of 1862.

A Postcard from the Past

Commander Beal been has successful in bidding on another old postcard from Santa Ana. The postcard was mailed on May 4, 1908 from Santa Ana to Mr. Emmett Daly in Martinez, CA. It is from the period that the 41st Annual Department of California & Nevada GAR Encampment along with Allied Orders was held in Santa Ana from April 8-10, 1908. The patriotic postcard was taken in front of the Parke S. Roper Book Store located at 210 W. Fourth Street in Santa Ana.



#### Charles Beal Acquires Rare Southern California Veterans Association Badge

Camp Commander Beal has acquired a rare Southern California Veterans' Association (SCVA) badge to add to his collection. The SCVA was originated by the Grand Army of the Republic Camps in southern California in August 1888. The first annual encampment was held at Anaheim Landing (near modern Seal Beach) on August 8-18, 1888; and was financed largely by the members of the Dan Bidwell GAR Post 140 of Norwalk, California. It was known as "The Seventh Inspection District Encampment of California", and continued to exist under that name until the Sixth Annual Encampment held at Santa Barbara in 1893, when

it was changed to the Southern California Veterans' Association. The badge of the Association was adopted at the 1893 Encampment.

The SCVA gave its membership criteria as. "All honorably discharged Soldiers, Sailors, and Marines of the Civil War, Spanish War, Mexican War, or of the regular army, their sons and grandsons are eligible to membership."

During the 13th Annual Encampment "Camp Fairchild" held at Long Beach in September 1900, the following resolution was adopted, "Defining the status of the Sons of Veterans; whereas, the Sons of



Veterans, as an organization, have never been recognized by the Southern

California Veterans' Association, and as our lineal descendants they are to fill our places and perpetuate our memory after we have answered the final roll call. Therefore be it resolved that hereafter the Sons of Veterans organization shall be recognized and adopted as a true and lawful auxiliary of our association and that they be accorded duties and prerogatives as follows: First, that the officer of the guard of this association shall be from their organization and elected by them; second, that under him shall be placed the active guard duty of the camp during our annual encampments, guards to be selected from the Sons of Veterans association; third, that they be given the left of the line in all marches and parades in which the parent organization participates and indulges.'

The SCVA held their encampments in August or September for ten days at various locations in Southern California from 1893 through 1937. SCVA Encampments were held at Huntington Beach, California from 1905 through 1923. The last fourteen encampments were conducted at Pacific Palisades.



The photo at the left is one in a collection of photos found by Charles Beal believed to be from the 1888 Encampment at Anaheim Landing. That was the first encampment of what became the SCVA Encampments.

### Sedgwick-Granger Camp 17 Sons of Union Veterans of the Civil War Minutes of Meeting – Sept. 20, 2012 Tustin, CA

7:05 Call to order by Commander Charles Beal

Brothers present: DeLoy Baker, Charles Beal, James "Jim" Blauer, Walter Davis, Marcus Deemer, George Dore, Joe Hart, Donald Hoffer, Greg "Doc" Lutes, Scott McKee, Glen Roosevelt, and Terry Shaw.

Opening prayer by Chaplain Scott McKee.

Pledge of Allegiance by Jim Blauer.

Commander Beal referred to National General Order No. 4 in the newsletter, which amends the National Constitution preamble to include the Marine Corps and Revenue Cutter Service as a result of a vote taken at the National Encampment in August 2012. The change must be ratified by all Departments.

Roll call was taken (see above for attendance).

Minutes of meeting of 5-17-12 submitted; motion by Joe Hart to approve, second by Scott McKee; motion carried. It was noted that a 7-19-12 informal meeting was conducted without Minutes taken.

Treasurer report - by Terry Shaw: balance at 8/31/2012 was \$1,964.87, income for May-August was \$100.00 (dues) and expenses totaled \$197.00 (various) for net expense of \$97.00. Year to date income was \$1,530.00 and expense was \$1,913.47 for net year-to-date expense of \$383.47. Motion by Joe Hart to approve, second by Greg Lutes, motion carried (refer to submitted spreadsheet for further detail).

Report on Brother's health/in distress:

John Heckman's passing and memorial service was referred to in the newsletter. Billy Hampton's current health status was not known.

Membership applications:

Dwayne McKnight (not present) submitted his application based on his third great grand uncle John D. Reasner. Motion to approve for membership by Glen Roosevelt, second by Joe Hart, motion carried. Brother George Dore was presented with his membership certificate.

Patriotic Hall update: Glen indicated construction may be finished by year end, they are determining allocation of space to potential users and they ran into issues with the parking lot.

Grave's registration: Charles is checking into potential new sites, he referred to the Commander's Corner in the newsletter regarding the recently acquired list of graves compiled by old Santa Ana Camp 12 Commander Roy Kelshner.

Civil War Memorials: no report.

Eagle Scout Certificates: Jim Blauer indicated it has been a slow year, due to his move mail was returned to sending parties and not forwarded to him and there has been personnel turnover at the Boy Scout Council.

Newsletter: articles on the National Encampment, upcoming events and JROTC awards were referred to.

SVR update: Glen indicated that Will Tisch is the new Commander of the Sixth District, replacing Dave

Allyn; Joe Marti is the new Public Information Officer; he further indicated that the SVR/Marine Corps Guard will participate at the Drum Barracks Anniversary Day and Museum Birthday on Sept. 22. Doc is signing up to be the SVR medic and Camp 2 PCC Tom Chumley's stepson Andrew Brown signed on as a Navy landsman.

Camp History: no report.

Old Business:

Santa Ana Cemetery GAR monument: Glen indicated that the Memorial Grant program window had been closed; suggested we contact cemetery regarding needed restoration.

28<sup>th</sup> Annual West Coast Civil War Conference was announced by Charles to be held November 2-4 in Costa Mesa at the Crowne Plaza Hotel. Joe spoke highly of the event.

New Business: none.

Good of the order:

Walter Davis indicated that the 150<sup>th</sup> anniversary of Antietam and the 225<sup>th</sup> anniversary of the --U.S. Constitution were marked on Sept. 17. He also mentioned that the 1940 census was available on the internet. Joe indicated that we obtained contact information on eight persons of interest at the Huntington Beach Labor Day weekend reenactment, two of which looked like good prospects to join the Camp. Joann Knowles, of the DUVCW and Civil War Round Table, expounded on the West Coast Conference discussed earlier. The conference topic will be 1862.

Charles reviewed materials from the National Encampment. Glen indicated that next year's National Encampment will be held near Milwaukee, WI. Glen announced that he still has this year's Encampment medals and mugs available for sale.

Charles indicated he had purchased a SoCal Veterans Assoc. badge from an encampment in Huntington Beach and a 1908 postcard of a store front in Santa Ana with a GAR star displayed from Ebay. Jim Blauer suggested that an Angel game opening be looked into with him singing the National Anthem and the SVR Color Guard participating.
