Camp Commander Beal Locates More Union Veteran Graves From Genealogical Society and Old Real Son's Lists

Camp 17 Commander Charles Beal has been working with the Orange County California Genealogical Society (OCCGS) in locating more than 60 additional Civil War veteran graves in Orange County. The OCCGS is digging deeper into the 1910 U.S. Census records (a person stated what war they served in on the census) and other local records and Internet searches for GAR members in Orange County, and the OCCGS is coming up with additional graves. A burial list created by Real Son Roy Kelchner, last Commander of old SUVCW Camp #12 of Santa Ana, that was given to Glen Roosevelt last summer by Roy's son Don has also added many more additional graves. Currently they are up to about the letter "D" of the last names.

Charles has been spending some of his weekends photographing and obtaining GPS coordinates on the new graves. He recently added another 2 new graves that he found on his wondering at Santa Ana Cemetery looking for other new graves. In addition, he is also helping OCCGS locate Spanish American War and WWI veteran graves for their future projects.

A new upright Civil War Monument was installed at Santa Ana Cemetery last month for Confederate Civil War veteran, George Taylor Stephenson. Charles helped assist the descendants who live in Texas to fulfill their dream of recognizing their Civil War ancestor who died in Santa Ana while visiting in 1905.

Gen. W.S. Rosecrans Camp 2 of Los Angeles participated in the L.A. Heritage Alliance Annual Los Angeles Heritage Day on Sunday, April 14, 2013, from 11am to 4pm at the Pico House and the Plaza at El Pueblo Historical Monument. Camp 17 PCC-PDC Glen Roosevelt helped out with the display that was supervised by Camp 2 SVC Nick Smith and Camp 2 Brother Dean Smith (no relation). The display featured the relationship of the Civil War Union Army to Los Angeles, and the four main GAR Posts of the downtown Los Angeles area. The display also featured information on Don Andres Pico and his involvement with the California Militia and the Los Angeles Company of the Native California Cavalry during the Civil War. The event offered a few recruiting opportunities for Camp 2, but more over provided an excellent chance for Nick Smith to interact and network with all the historical societies of Los Angeles County that

were represented at the event. The Camp's next door neighbor booth was Lou Lopez who sponsors the Fort MacArthur Military History event in July.

# Camp 17 at "Battle of Costa Mesa" ACWS Civil War Reenactment

Camp 17 set up a display booth on Sunday, April 21, 2013 at Fairview Park in Costa Mesa. The display was arranged and commanded by Camp 17 Secretary-Treasurer Terry Shaw who is also an officer in the Costa Mesa Historical Society. Camp 17 SVC Joe Hart and PCC-PDC Glen Roosevelt helped staff the booth. The weather was perfect, and the location on the bluffs overlooking the Santa Ana River provided an excellent venue. The display featured information on the Huntington Beach GAR Encampments from 1905-1923; and also information on Civil War veteran James Talbert who founded Fountain Valley (originally named Talbert) who is buried in nearby Good Shepherd Cemetery, and Charles Chappell who was the last Union Civil War veteran buried in Orange County at Westminster Cemetery. The display booths of the Orange County Civil War Roundtable and DUVCW Tent 88 were close at hand.

Roll call was taken (see above for attendance)

**Minutes of meeting of 1-17-13** submitted; motion by Walter Davis to approve, second by Jim Blauer; motion carried .

**Treasurer Report** - by Terry Shaw: balance at 2/28/2013 was \$1,842.29, income for Jan-Feb. was none (however \$1,320.00 dues had been collected and were pending deposit), and expenses totaled \$79.20 for net expense of \$79.20. Year to date income was \$0.00 and expense was \$79.20 for net year-to-date expense of \$79.20. Motion by Joe Hart to approve, second by Glen Roosevelt, motion carried. Commander Beal reviewed General Orders issued by National and Department and incorporated herein by reference.

#### Report on Brother's health/in distress:

Marcus Deemer reported that his brother, Bob, passed away Jan. 17. Charles reported that his family and Mother face on going issues as a result of her stroke. Glen reported that Doc Lutes was suffering a respiratory infection and there was a death in the family. Charles had recovered from a severe bout of flu. Jim was present with us after continuing recovering from a heart attack.

**Membership applications:** Brother Art Scully of Camp 9, which is in the process of dissolving, recently moved to Orange County and was interested in transferring to Camp 17.

#### **Old Business:**

Battle of Costa Mesa reenactment would be held 4/20-21 and Terry requested help in manning a display booth on Sunday 4/21.

Memorial Day: Charles indicated it was a work in progress.

Civil War Memorials: Charles reported that the Eagle Monument restoration at Santa Ana Cemetery is finished.

Graves Registration: Charles reported that a headstone has been ordered for Confederate veteran George Stevenson at Santa Ana Cemetery.

Patriotic Hall: Glen reported that the L.A. Dept. of Military & Veterans Affairs was scheduled to move in May. Contract with curator to sort and recommend display items from the artifacts collection is to start by May 1. Glen is to work on team.

Department Encampment: Glen reported that three from our Camp attended (Glen, Joe and Terry). Joe Hart presented the Camp report – see newsletter for more.

National Encampment: Glen reported that a final audit for the 2012 National Encampment was pending but preliminary numbers show an approximately \$8,000.00 surplus; operating income showed a loss of \$900.00 but fund-raiser items raised the income to \$1,300.00. Significant targeted donations created the surplus which may be returned to donors or otherwise directed by the Department Encampment.

Redlands Lincoln Pilgrimage was attended by Camp 17 Brother Michael Hicks and Camp 18 Brother Ken Walker who acted as an honor guard.

George Washington Massing of the Colors: Glen was ill and could not attend, and there was no SVR representation. Also Jim Blauer was still recovering from his heart attack and did not attend to sing the National Anthem as he usually does.

St. Catherine's Civil War Weekend: three of us (Glen, Joe and Terry) manned a booth – see newsletter for additional information.

Website payment: Charles initiated discussion of payment for our website to the Dept. Walter moved that we pay \$25.00; seconded by Joe and passed.

Raffle: starts tonight, Don selling tickets. The proceeds were \$83.00.

#### New Business:

Tri-City Memorial Day Service: Charles and Scott said no donation is needed. The 150th anniversary of Gettysburg will be commemorated along with the 200th anniversary of the War of 1812, and the Eagle Monument will be rededicated. Glen suggested that the Eagle Monument be rededicated in 2015 on its 100th anniversary, and current Iraq-Afghanistan veterans be acknowledged at this time.

#### For the good of the order:

Flag placement: Charles indicated flags will be placed on veterans' graves at 08:00 on Saturday May 25 at Santa Ana Cemetery.

May 16 Camp meeting program: Joe announced the speaker will be Tent 88 DUV Claire Winder Kyllingstad presenting her book "Out of Ricketts Battery...The Civil War Diary of Hiram Pidcoe".

Scott announced that his son, Brother Ed McKee, was now a PFC in the US Marines (Reserve) assigned to a artillery unit and was planning to apply to LAPD in 2014.


Upcoming events: all were encouraged to refer to the newsletter.

# Civil War Ironclad Presentation at March 21, 2013 Meeting

The presentation at our March 21 Camp meeting was one of the best ever. Great thanks to SVC Joe Hart for arranging our speaker, but most of all thanks to Mr. Steve Lund for his outstanding discussion and display of ironclad vessels from the Civil War. Steve explained how the innovations of the ironclads changed the nature of naval warfare throughout the world. Besides the obvious and famous designs and the battle of the Merrimac (CSS Virginia) and the Monitor, there were many more ironclads whose concepts led to the dreadnoughts of the future navies.

Mr. Lund also left us with the tempting information that the remains of the first Civil War ironclad on the west coast, the Camanche, lies within easy view in the shallow waters of Alameda Bay in northern California. Steve suggests that all is needed is some entity to step forward to spearhead a project to retrieve and preserve the remains of this historic vessel.
