The California Society SAR Lee's Legion Color Guard, led by former Camp 17 Brother Jim Fosdyck, presented the colors and also sponsored a wreath. The ceremony included presenting the colors, invocation, Pledge of Allegiance, "God Bless America" sung by Camp 17 Brother Jim Blauer. Wreaths were also presented by Camp 17 Past Commander Charles Beal on behalf of the Camp, and by DUVCW Tent 88 represented by Tent President Charline Grundmann and four other Sisters. THE COMMUNITY FOUNDATION OF ORANGE WRAPS UP ITS FIRST FIELD OF VALOR Honoring Veterans Day Nov. 7 – 11 , 2015

"I am not sure if I have the words to describe the Field of Valor...it was powerful yet beautiful; there was joy along with sadness; new friends were made and old friends were reconnected. Some Veterans got their first recognition for their service to our great country – and they shed a lot of tears. It was simply incredible," said an exhausted, yet thrilled Gary Remland, President of the Community Foundation of Orange and Chairman of the Field of Valor Committee as he was loading the last of 1776



American flags onto a truck headed for storage. What took an army of over 100 volunteers from the Home Depot (at Tustin and Taft in Orange), CFO board members and their families, local Veterans, and members of the Orange High School Football team over eight hours to set-up on Saturday the 7th, was taken down in under an hour Thursday morning. 50-plus volunteers led by members of the Chapman University Football team and Head Coach Bob Owens, Chapman Lacrosse teams, Women's Basketball team including Head Coach Carol Jue, Chapman Vice Chancellor/CFO board member Mike Pelly, and Orange City Councilman Mike Alvarez, as well as Home Depot associates, CFO board members and their families, and those who attended the event and "just wanted to help" were all focused on getting the job done and leaving Handy Park as they found it six short days ago, and did so in no time. Remland continued, "Our goal was to honor those who have served and are serving us to protect our freedom and then to raise some money that will go toward helping those established organizations who are doing good work for veterans and active duty military & their families in our community. Our goal was to bring our community, not only in the City of Orange, but in the surrounding cities and essentially all of Orange County, together as a community. I can say without a doubt that our goals were achieved and our mission for this event was accomplished.

Still tabulating final figures, CFO Executive Director Susie Cunningham stated, "We had 917 flags sponsored; over 400 of those were sold on site. This was the Foundation's first foray into Veterans' causes and the response was simply unbelievable. Thanks to great coverage in the news and on social media, we were able to attract folks from all over Orange County to our Field of Valor! The stories that were shared for the tribute cards and the sacrifices that were made by these troops – and their families were simply humbling. Now that people are aware of CFO and the Field of Valor, I cannot wait to see what the turn-out will be for next year's event!"The Community Foundation of Orange could not have made the Field of Valor happen without help – through sponsorships, in-kind donations, individual flags sold and with hundreds of volunteers working unselfishly. The Orange City Council generously authorized the CFO's use of Handy Park; Community Services Director Marie Knight and Senior Landscape and Project Coordinator Don Equitz were just two of the City of Orange employees who volunteered their time and expertise to the event. Major sponsors for the Inaugural Field of Valor were The Home Depot (Tustin St and Taft in Orange) and Catherine Sorensen, along with Ashley Home Furniture, Milan Capital Management and Remland Insurance.Remland looked out on the now-clean field with a smile, "On behalf of the Community Foundation of Orange, thank you to all who gave to this community effort; we are so grateful. 
Thanks to all our Camp 17 Brothers for their efforts throughout the year to keep our Camp vital, and to honor and preserve the history and service of their ancestors and all our Union Veterans of the Civil War.

Camp 17 Brothers Visit Ancestors Battlefields in August 2015

Camp 17 PCC Glen Roosevelt and Camp 17 Brother Mike Roosevelt completed a drive-in and fly-in rendezvous in Dallas, Texas in mid-August 2015, and they were able to drive through Louisiana and Mississippi to visit the Mansfield State Battlefield Park in Louisiana, and the Vicksburg National Battlefield Park in Mississippi. Their ancestor, Private Jacob D. Stroud of Company H, 23rd Wisconsin Infantry fought at both places, and was killed at Mansfield (Sabine Crossroads).

The area where the regiment fought at Mansfield is not yet an open part of the Park, but it was an emotional experience to stand within a few hundred feet of where our ancestor fought and died. It is interesting to note that the ancestors of Camp 17 Brothers Charles Beal, Rick Snyder, former Camp Brother Mike Quigley, and Camp 18 Secretary Rudy Velasco all had ancestors that fought at Mansfield.

At Vicksburg we drove the 8-mile loop roadway of the battlefield area, stopping at the locations that the monuments depicted various locations for the 23rd Wisconsin throughout the battle and siege of the Confederate stronghold. Another highlight of the Vicksburg trip was visiting the preserved remains of the ironclad USS Cairo which was raised some years ago from the depths and mud of the Yazoo River north of Vicksburg. The Brothers intend to make the trek back to Vicksburg in 2016, and walk the 8-mile loop to get a closer look at all the features of the Park. We encourage all our Camp Brothers to visit the places their ancestors served, and to share those visits with the Camp.



Nominated to serve as the executive director of the U.S. Civil War Centennial Commission.


Named a charter member of the Virginia Sesquicentennial of the American Civil War Commission.

Dr. Robertson also has edited an additional 18 books on the Civil War.


