Pledge of Allegiance by Denny Dettmer.

Roll call was taken (see above for attendance).

Minutes of meeting of 9-21-17 were submitted by Terry Shaw; motion by Glen Roosevelt to approve, second by Scott McKee, motion carried.

Treasurer report - submitted by Terry Shaw:

Sept.-Oct., balance at 10/31/2017 was \$3,389.05, income for September - October was \$0.00 and expenses totaled \$20.00 (rent) for net loss of \$20.00. YTD income was \$1,114.00 and YTD expenses were \$896.88 for YTD net income of \$217.12. Motion by to approve by Glen Roosevelt, second by Scott McKee, motion carried.

Membership applications – Denny Dettmer indicated he wanted to be reinstated and would send dues for 2017 (dues subsequently received).

#### Brothers in distress, etc.:

Glen Roosevelt informed us that Brother Dan Henry would be moving to Nashville in December. Charles Beal informed us that Vivian Owen, trustee with the Orange County Cemetery District, had passed away.

#### New Business:

Glen Roosevelt, PDC/PCC, initiated elections:

Camp Commander – George Dore nominated by Glen Roosevelt, second by Scott McKee, elected. Sr. Vice Commander – Cole Zehnder nominated by Glen Roosevelt, second by Charles Beal, elected. Jr. Vice Commander – Scott McKee nominated by Glen Roosevelt, second by George Dore, elected. Secretary-Treasurer – Terry Shaw nominated by Glen Roosevelt, second by Scott McKee, elected. Camp Council - Glen Roosevelt, Charles Beal and Dennis Dettmer nominated by George Dore, second by Scott McKee, elected.

Meeting turned back over to Commander Dore

Scott McKee suggested having the Camp's January 2018 meeting at the Santa Ana American Legion Post on 1/1//18 at 6:30pm. Glen Roosevelt agreed pending OK by other tenants at the hall.

Discussion took place about the new lease presented by Orange County Church prior to the start of our meeting. Glen Roosevelt proposed a permanent move to the Santa Ana Veterans Hall pending tenant approvals and further discussion at the January meeting, Charles seconded, passed.

Charles Beal announced he would be conducting a cemetery tour for the Orange County Library librarians on Dec. 20 (the date was later determined to be Dec. 27) at Santa Ana Cemetery.

Scott McKee informed us that the "CSA Iron Cross" had been removed (stolen per follow-up information and clarification) from the Confederate Monument at Santa Ana Cemetery.

#### **Santa Ana Cemetery Tour**

PCC Charles Beal conducted a two-hour walking tour of military graves at Santa Ana Cemetery on December 27, 2017. The tour was for a dozen Orange County Librarians interested in local history. The majority of the graves on the tour were related to the Civil War. There are 353 (304 Union and 49 CSA) known Civil War veteran graves at Santa Ana Cemetery.

The USVI was made up of captured Confederate soldiers who took an oath of allegiance to the United States, and were willing to serve as US troops. The USVI regiments were sent to the northwest to fight or protect against Indian raids.

In 2017, during the graves registration work that was conducted by Edna Cardinal and myself. we located 10 new Civil War Veteran graves in Orange County. We also located another 182 Spanish American War Veteran graves.

In 2009 a Civil War grave marker for Alfred Walter Hill was placed at his unmarked gravesite at Santa Ana Cemetery. New information came out last year indicating that the widow had falsely published an obituary in the local Orange News newspaper saying he was a Civil War Veteran, so she could claim his military pension. Further investigation shows that Alfred's son is buried at the Santa Ana Cemetery gravesite; and Alfred Hill is buried at Riverside Cemetery, Gas City, Indiana. Find-A-Grave.com shows a photo of his Civil War grave marker, that was published over two years after his Civil War grave marker was installed at Santa Ana Cemetery. The Orange County Cemetery District will remove the Civil War grave marker for Alfred Hill at

Edna Cardinal and myself have created a new graves registration project for Orange County. We now are documenting and locating all war era veteran graves from the War of 1812 to the Spanish American War. The breakdown of the graves that we have documented through 2017 is:

War of 1812: 1 Mexican War: 12 Indian Wars: 6

Civil War: 853 (752 US and 101 Confederate veterans)

Spanish American War: 443

Total War Veteran Graves located: 1,315
