

His application is based on the service of his 3rd-great-grandfather, David Granville Overfelt, who served as a Private in Company D, 33rd Kentucky Infantry from 31 October 1862 to 28 February 1863. Steven presented his application with secondary support documentation, and he is waiting for copies of the primary documents to arrive from the National Archives. He is a self-described "Genealogy Geek", and he belongs to many hereditary organizations.

Minutes of meeting of 1-18-18 were submitted by Terry Shaw; motion by Glen Roosevelt to approve, second by Charles Beal, motion carried.

Treasurer Report - submitted by Terry Shaw:

Glen Roosevelt submitted a receipt for reimbursement for three new name badges for \$47.68; Scott McKee motioned to accept, Paul Sapp seconded, motion carried.

Charles Beal moved to allocate \$62.50 for the Memorial Day Wreath, Jon Crum seconded, motion carried. Scott Mckee reminded us that Memorial Day was coming up as well as flag planting on the Saturday before. A planning meeting was scheduled for Friday March 23.

George Dore announced the Civil War conference to be held in Temecula on June 2.

Terry Shaw updated us on members with dues outstanding. Glen Roosevelt will contact two and Terry the other two. A deadline was set for April 1; if the member cannot be reached or no commitment made by them, they will be honorably discharged.
