

Tri-City Memorial Day Ceremony Monday, May 28, 2018 at Santa Ana Cemetery GAR Plot & Monument

Camp 17 again had a strong presence at the Santa Ana Cemetery Tri-City Veterans Memorial Day ceremony. The event theme highlighted the American veterans of the Revolutionary War; and included a keynote presentation by SAR George Washington impressionist Daniel Shippey. As in previous years the Master of Ceremonies was Camp 17 JVC-Chaplain Scott McKee of the Santa Ana VFW/American Legion. Camp colors and wreath presentations during the ceremony were given by Camp 17 Commander George Dore and Brother Paul Sapp, and Secretary / Treasurer Terry Shaw. Charles Beal once again acted as our press photographer. Camp 17's good friend M/Sgt. "Jay" Jaenichen (USMC-Ret.) again provided the set-up and teardown of his "soldier crosses" before and after the ceremony. DUVCW Tent 88 President Charline Grundmann and Tent Sisters were present in force, and took part in the presentation of colors and wreaths. PCC Roosevelt participated in the American Legion ceremony at the GAR Monument in Corona Sunnyslope Cemetery at the same time as the Santa Ana ceremony took place.

7:18 Call to order by Commander George Dore

Brothers present: Charles Beal, George Dore, Scott McKee, Paul Sapp, Terry Shaw and Steven Steinberg

Opening prayer by Scott McKee Pledge of Allegiance by Charles Beal Roll call was taken (see above for attendance)

Minutes of meeting of 5-17-18 were submitted by Terry Shaw; motion by Steve Steinberg to approve as submitted, second by Paul Sapp, motion carried.

Treasurer Report - submitted by Terry Shaw:

May-June: balance at 6/30/2018 was \$3,648.45, income for May-June was \$50.00 (dues) and expenses totaled \$99.92 (\$62.50 wreath, \$24.50 per capita dues paid) for net loss of <\$49.92>. YTD amounts were income of \$1,150.00 and expenses of \$884.60 for YTD net income of \$265.40. Motion by to approve by Scott McKee, second by Steve Steinberg, motion carried.

Membership applications, etc:

Jim Klingler, an SAR member, submitted an application. However, further documentation was needed. Cole Zehnder will be transferring to another Camp (18) at some point.

Brothers in distress, etc:

Scott McKee reported that his son and Camp Brother Ed McKee made "expert rifleman"; and will be facing "the Crucible" on July 25 as the final major hurdle at Marine boot camp.

Old Business:

By-laws: discussion took place concerning the proposed new Camp By-laws to accommodate required changes by National using a template provided by the Department as well as to retain some passages in our existing By-laws. Further changes were made to article VI, section 3 and article VIII, section 2. Scott McKee moved for adoption of first reading of By-laws including proposed changes with the second reading and final adoption at the September 20, 2018 meeting. Paul Sapp seconded, motion carried.

Huntington Beach: Steve Steinberg indicated that the United Daughters of the Confederacy were interested in partnering with the DUVCW or us if the DUVCW did not have a booth. With no formal decision taking place, the consensus was that we would provide their information if an inquiry were made.

New Business/For the Good of the Order:

Terry indicated an email had been sent out from National via the Department with a link to a survey to assist in future planning.

Steve suggested the Camp look into social media to promote the group. George appointed Steve to research further.

Charles indicated he received an okay from Fairhaven Cemetery to apply for eleven markers for veterans from the Civil War, Spanish-American War, and post Spanish-American War. Fairhaven is waving installation fees.

Scott announced that a 9/11 Memorial Ceremony would be held at the American Legion Hall on 9/11. George announced that Steve Demory would be making a presentation on the US Balloon Corps at the Sept. 20 meeting.

This month I will be submitting VA Form 40-1330 for military markers for 10 unmarked graves (Civil War, Spanish American War and Moro Rebellion - Post Spanish American War in the Philippines) at Fairhaven Memorial Park in Santa Ana. Fairhaven has been gracious enough to waive the installation fees for the new markers to be installed upon delivery.

I've also been working with Fairhaven on a stolen VA marker for Spanish American War Veteran Charles F. Wood. I discovered that his original VA bronze marker had been stolen last year. The new marker was installed last month at his grave-site.
