
The 2018 appointed officers were Glen Roosevelt as Counselor and Patriotic Instructor, James Blauer as Eagle Scout Coordinator, Scott McKee as Chaplain, Charles Beal as Historian, Glen Roosevelt as Newsletter Editor and Signals Officer, Charles Beal as Historian, Graves Registration and Memorials Officer, Don Hoffer as the Guide, and the GAR Highway Officer is Glen Roosevelt. The Color Bearer and Guard were not filled during 2018. The newly elected 2019 Camp officers and the appointed officers will be installed at the January 2019 Camp Installation meeting at the Santa Ana American Legion / VFW Hall. We will also observe the Camp's 16th Anniversary with our traditional birthday cake and other refreshments during the January 2019 meeting.

Camp 17 & Santa Ana VFW / American Legion Honor WW1 Veterans

Camp 17 GRO Charles Beal organized a flag placement day at Santa Ana Cemetery on Saturday, November 10th to honor the World War I Veterans buried there for the 100th anniversary of the end of the war. There were about a dozen volunteers, including Camp 17 Cmdr. George Dore, JVC/Chaplain Scott McKee who is also a member of the Santa Ana VFW/American Legion. Along with VFW District 2 Commander – Santa Ana Post 10694 Adjutant / QM Janine Fountain, the Young Marines from Tustin showed up to help place flags on the graves. In total, the group placed 91 flags with a poppy tied to the top of the staff.

Charles did an inventory and photographed all the markers afterwards; and located some of the private graves that he knew about. He created a master list from 2 other existing lists of veteran graves created in the 1990s for Santa Ana Cemetery. That gave him an idea that there were about 100 potential WWI graves at the cemetery. A majority of the graves had VA markers, and a few had

private markers. In the above number were 5 new graves that weren't on either of the 2 lists as WWI. Four of those graves were VA markers without WWI mentioned on them, and 1 military marker with WWI on it. Ten markers were not located, so some more work needs to be done on them if they exist. There are probably more with private markers, but that can take a lot of time to research and locate those. A few of them may be located at adjacent St. John's cemetery. Graves Registration Update

Last month Charles ordered a VA marker for Pierre/Peter Lehnen who is buried in an unmarked grave at Holy Cross Cemetery in Anaheim. Pierre was a Private in Company H, 2nd Wisconsin Calvary.

Charles's 10 unmarked VA applications at Fairhaven were returned to him saying that we can't order bronze markers for Civil War and Spanish American War era graves. Bronze markers for Civil War and Indian Wars Veterans have been ordered in the 1990s and 2000s in Orange County. He inquired with the VA and was told that the VA historians are trying to be historically correct (even through the VA has been doing it wrong for years); and the historians are the ones pushing for specific era issued markers now. So, the choices are granite or marble. The VA suggested upright markers, but Fairhaven won't allow that. So, he has ordered granite flat markers.

All 10 markers at Fairhaven were approved with an expected delivery in 30-45 days.

- 7. John Lewis (Private in Co. E, 2nd Nebraska Cavalry, and Co. I, 43rd Missouri Infantry)
- 8. Lester Young (Private in Co. A, 28th Michigan Infantry)

Spanish American War:

1. Wallace Williard (Farrier in Co. A, 1st U.S. Calvary - Rough Riders)

Post Spanish American War:

1. Walter Boyle (Private in U.S. Army, Company I, 13th U.S. Calvary that served in the Moro Rebellion (Philippines) after the Spanish American War. Also served in 115th Co. Coast Artillery Corps, and the Hospital Corps)


More recently Joe took a tour of the Capitol
