Section 1: On August 31, 2018, the Commander in Chief, issued General Order # 1, Series 2018-2019. Two of his goals, which apply to our Camp, are: a substantial progress in membership growth and retention; and, increased public awareness of the Order—"We should no longer be the best-kept secret in America." All members of Camp 2 are, therefore, encouraged to: (1) consider relatives, friends, and acquaintances as potential members of the SUVCW, and to connect anyone interested in learning more about joining, with our Junior Vice Commander, Brother James Gill; and, (2) look for opportunities to represent the Order at public events, local schools, and through being a presenter of ROTC/JROTC awards, and Eagle Scout certificates of commendation.

ANNUAL MEMBERSHIP DUES

By the authority vested in me, as Commander of Gen. W. S. Rosecrans Camp, No. 2, Department of California and Pacific, by the Camp Bylaws, the Department Bylaws, the National Constitution and Regulations, and National Policies, it is hereby ordered, as follows:

Section 1: Pursuant to Article VI, Membership Dues and Fees, the Camp Commander shall issue Camp Orders announcing any change in the dues, not less than three months prior to the change.

Section 2: At its Camp meeting, on May 11, 2019, the Brothers assembled, voted unanimously, to increase the annual dues by Four Dollars (\$4.00,) effective January 1, 2020, and by an additional Five Dollars (\$5.00,) effective January 1, 2021. These increases will bring the total amount due for 2020, to Forty-five Dollars (\$45.00,) and to a total amount due for 2021, to Fifty Dollars (\$50.00.)

Section 3: The Camp's Brothers took this action, in recognition of the fact that the Camp's portion of their dues was just \$13.00, which does not generate sufficient funds for the Camp's Treasury, to meet the expenses of the Camp.

Section 4: Pursuant to Section 3, of Article VI, annual dues are payable on January 1<sup>st</sup> of each year. Brothers will be given notice of the dues being due, at least thirty (30) days before they are due. Dues not received by February 1<sup>st</sup>, shall be considered late, and the Five Dollar (\$5.00) late fee, prescribed by the Bylaws, will be enforced. Collecting dues by February 1<sup>st</sup> is necessary for completion of From 27, the Camp's Annual Report, which has to be presented at the annual Department Encampment, held each year in the month of March.
