#### SPECIAL COMMITTEE ON THE 2005 NATIONAL ENCAMPMENT

By the authority vested in me as Commander of the Department of California and Pacific, by the Department Bylaws, the National Constitution and Regulations, and National Policies, it is hereby ordered as follows:

<u>Section 1</u>: **DESIGNATION OF SPECIAL COMMITTEE**. The "Special Committee on the 2005 National Encampment" is hereby created, and shall remain in existence for sixty (60) days beyond the conclusion of the 2005 National Encampment if the National Organization agrees to allow the Department of California and Pacific to host the said Encampment. Upon a decision by the National Organization to have another Department host the 2005 National Encampment, this special committee shall be terminated and cease to exist sixty (60) days after said decision becomes known.

Section 2: **PURPOSE**. The purpose of this special committee is as follows:

#### **FY 2002 DEPARTMENT BUDGET**

(adbridged version as submitted by Dept. Secretary-Treasurer Daniel R. Earl)

By the authority vested in me as Commander of the Department of California and Pacific, by the Department Bylaws, the National Constitution and Regulations, and National Policies, it is hereby ordered as follows:

Section 1: The Fiscal Year, for purposes of our Department Budget, shall begin sixty (60) days after the conclusion of a Department Encampment, and run continuously until sixty (60) days after the conclusion of the following Department Encampment.

#### NATIONAL ENCAMPMENT SITE COORDINATOR

By the authority vested in me as Commander of the Department of California and Pacific, by the Department Bylaws, the National Constitution and Regulations, and National Policies, it is hereby ordered as follows:

<u>Section 1</u>: There is hereby established an appointive position to be known as the National Encampment Site Coordinator (hereinafter, "Coordinator") for the Department of California and Pacific. The position shall be responsible for coordinating, at the Department level, any National Encampment that may be held within the jurisdiction of the Department of California and Pacific. The position is also responsible for acting as liaison to the National Encampment Site Committee for the Sons of Union Veterans of the Civil War. ## DEPARTMENT ORDER No. 11 Series 2002-2003

#### PLEDGE OF ALLEGIANCE & NATIONAL MOTTO

By the authority vested in me as Commander of the Department of California and Pacific, by the Department Bylaws, the National Constitution and Regulations, and National Policies, it is hereby ordered as follows:

<u>Section 1</u>: The Pledge of Allegiance is as follows: *I Pledge Allegiance to the Flag of the United States of American, and to the Republic for which it stands, one Nation under God, indivisible, with liberty and justice for all. The National Motto is: <i>In God We Trust*.

<u>Section 2</u>: On 26 June 2002 a three-judge panel of the United States Court of Appeals for the Ninth Circuit ruled in the case of *Newdow v. United States Congress* that the words "under God" in the Pledge of Allegiance are unconstitutional as "a religious act" in violation of the Establishment Clause.

<u>Section 3</u>: On 28 February 2003 the full U.S. Court of Appeals for the Ninth Circuit amended its Order of June 2002 by refusing to rehear the *Newdow* case. The Court subsequently stayed its own decision, pending an appeal to the United States Supreme Court.

<u>Section 4</u>: The American Family Association (AFA), in cooperation with WePledge.com, is trying to secure ten million signatures for a constitutional amendment to save the Pledge of Allegiance and our National Motto. Their website is: http://www.wepledge.com.

<u>Section 5</u>: There are currently two pieces of legislation that have been introduced in Congress and would accomplish the goals of the AFA. In the House of Representatives: H.J.Res. 26 (introduced on 27 February 2003 by Congressman Lucas of Oklahoma), proposing an amendment to the Constitution of the United States to protect the Pledge of Allegiance. Its companion Bill in the Senate is S.J.Res. 7 (introduced 3 March 2003 by Senator Landrieu of Louisiana), proposing an amendment to the Constitution of the United States relative to the reference to God in the Pledge of Allegiance and on United States currency. Both Bills have been assigned to their respective committee on the Judiciary where they are awaiting further action.

<u>Section 6</u>: Brothers are encouraged to sign the electronic petition at www.wepledge.com and to write their representatives in Congress in support of maintaining the words "*under God*" in the Pledge of Allegiance and preserving the words "*In God We Trust*" as our National Motto.

## IN MEMORY OF MRS. GERTRUDE JANEWAY, THE LAST WIDOW OF A UNION CIVIL WAR VETERAN

By the authority vested in me as Commander of the Department of California and Pacific, by the Department Bylaws, the National Constitution and Regulations, and National Policies, it is hereby ordered as follows:

<u>Section 1</u>: WHEREAS, Gertrude "Gertie" (Grubb) Janeway, the oldest of four children and wife of the late John (January) "Janeway", was born 93 years ago in Blaine, Grainger County, Tennessee, 44 years after the Civil War ended, where she quietly passed away on Friday, 17 January 2003 in the three-room log cabin where she lived most of her life; she is survived by many nieces, nephews, and friends; and.

WHEREAS, Miss. Grubb, at age 18, married John "January" Janeway, aged 81, on 9 June 1927 "in the middle of a dirt road at 9 a.m." in Grainger County, Tennessee; and,

WHEREAS, John Janeway left home in 1864 to join the Union Army, where he enlisted under the name "John January" in Company B, 14th Illinois Cavalry. John died in 1937; and,

WHEREAS, The first photograph taken of Mrs. Janeway was with her husband when she was 20 years old and he was 82 years old; and,

WHEREAS, Mrs. Janeway was a founding member of the Green Acres Baptist Church in Knoxville, TN, and was an honorary member of the Sons of Union Veterans of the Civil War; and,

WHEREAS, Mrs. Janeway was the last surviving widow of a Union Civil War veteran, her funeral was held Sunday, 19 January 2003, where the Rev. Leonard Goins, who officiated, described her as "a special person;" she was laid to rest next to her husband, John, at the New Corinth Cemetery; now, therefore be it

*RESOLVED*, that the Brothers of the Department of California and Pacific express their profound sympathy to the family and friends of the late Mrs. Gertrude "Gertie" (Grubb) Janeway.

<u>Section 2</u>: In memory of Mrs. Janeway, the Department Charter shall be draped in black for a period of thirty (30) days following the funeral of Mrs. Janeway.
