# Special Committee to Explore the Possibility of Coordinating Joint Activities between the SUVCW/ASUVCW Department of California and Pacific and the Sons of Confederate Veterans California Division in 2020.

By the authority vested in me as Commander of the Department of California and Pacific, by the Department Bylaws, the National Constitution and Regulations, and National Policies, it is hereby ordered as follows:

<u>Section 1</u>: Several years ago, the Special Committee to Explore the Possibility of Coordinating Meetings and/or Activities of the SCV California Division Convention and SUVCW/ASUVCW Department Encampment in 2020 was created. During its report at the 133<sup>rd</sup> Annual Department Encampment, on 23 March 2019, at Bakersfield, California, the Committee had no recommendations, but concluded it was unlikely such activities could be achieved in 2020. The committee was then discharged. Delegates unanimously requested the Department Commander for 2019-2020 appoint a special committee to further investigate possibilities of such activities in 2020 and future years.

<u>Section 2</u>: I am hereby establishing the Special Committee to Explore the Possibility of Coordinating Joint Activities between the SUVCW/ASUVCW Department of California and Pacific and the Sons of Confederate Veterans California Division.

The purpose of this special committee is to examine the feasibility of conducting joint functions between the Department of California and Pacific, SUVCW/ASUVCW and the California Division of the Sons of Confederate Veterans during their respective state-level conventions in 2020 or for future conventions.

Section 3: This special committee shall:

- a) Serve through the close of business at the 134<sup>th</sup> Annual Department Encampment of the Department of California and Pacific, SUVCW, at which time it shall be discharged of its duties and cease to exist.
- b) No later than ninety (90) days after issuance of this Department Order, the Committee shall report to the Department Commander its findings and recommendations for the likelihood of joint SUVCW/SCV activities during the 2020 conventions.
- c) The Committee shall determine the practicality of pursuing the likelihood of joint SUVCW/SCV activities during future conventions after 2020.
- d) The final decision on whether to pursue the possibilities of joint SUVCW/SCV activities during future conventions shall be determined by the Department Senior Vice Commander, who shall report the Special Committee's findings and recommendations at the 134<sup>th</sup> Annual Department Encampment.

<u>Section 4</u>: I hereby appoint the following members to this special committee: Department Senior Vice Commander Frank C. Avila as chairman; Brothers Linn W. Malaznik and Steven H. Steinberg as members; Sisters Cindy Eddy (PAP) and Rachelle Campbell (PNP) to serve as ASUVCW liaisons to the special committee; and Sons of Confederate Veterans, California Division Chief of Staff Jon Fowler to serve as SCV liaison. As Department Commander, I will serve as an *ex officio* member of the special committee.

# **Observance of Memorial Day 2019**

By the authority vested in me as Commander of the Department of California and Pacific, Sons of Union Veterans of the Civil War, by the Department Bylaws, the National Constitution and Regulations and National Policies, it is hereby ordered as follows:

<u>Section 1</u>: Upon becoming members of the Sons of Union Veterans of the Civil War, we pledged ourselves for the purpose of, and among other things, *to always observe the day set aside by the Grand Army of the Republic as Memorial Day, sacred to the memory of the Union Soldiers, Sailors and Marines of 1861 to 1865.* 

<u>Section 2</u>: Grand Army of the Republic Commander-in-Chief John A. Logan's General Order No. 11 instructs us that **The 30<sup>th</sup> day of May** (1868) is designated for the purpose of strewing with flowers or otherwise decorating the graves of comrades who died in the defense of their country during the late rebellion, and whose bodies now lie in almost every city, village and hamlet churchyard in the land. In this observance no form or ceremony is prescribed, but Posts and Comrades will, in their own way, arrange such fitting services and testimonials of respect as circumstances may permit.

<u>Section 3</u>: Camps and Brothers are encouraged to participate in the observance of Memorial Day on Thursday, May 30<sup>th</sup> or as circumstances permit May 25 through May 27.

<u>Section 4</u>: Remembering the Boys in Blue and rendering such fitting services and testimonials of respect can be an elaborate ceremony with many or a single Brother decorating a lone isolated and almost forgotten grave.

<u>Section 5</u>: Sentiments that endure to this day that link us to the Grand Army of the Republic, of honored memory, are acknowledged in the **Sons of Veterans Creed** and are as follows;

- To be a true American and a good citizen.
- To discountenance disloyalty in any form.
- To revere the name of my ancestor who gave his service and made his sacrifices for the maintenance of the Republic.
- To assist the Grand Army of the Republic and to perpetuate the patriotic teachings of that organization.
- To be loyal to my Camp and the Order and faithful to my fellow members that we may work in brotherhood for these ends.

# 134<sup>th</sup> Encampment Postponed

By the authority vested in me as Commander of the Department of California and Pacific, Sons of Union Veterans of the Civil War, by the Department Bylaws, the National Constitution and Regulations and National Policies, it is hereby ordered as follows:

- Section 1: With the number of confirmed COVED-19 cases in the Nation growing daily and in compliance with the increasing number of guidelines being issued at the National, State and local levels related to curbing the spread of the coronavirus, the 2020 Department Encampments of the Sons of Union Veterans of the Civil War and Auxiliary to SUVCW, scheduled for 20-21 March have been indefinitely postponed.
- Section 2: The health and safety of our SUVCW Brothers, Auxiliary Sisters and members of the Allied Orders, remain a top priority.

# **Memorial Day Order 2020**

By the authority vested in me as Commander of the Department of California and Pacific, Sons of Union Veterans of the Civil War, by the Department Bylaws, the National Constitution and Regulations and National Policies, it is hereby ordered as follows:

<u>Section 1</u>: When we were initiated into the Sons of Union Veterans of the Civil War we pledged ourselves to support and defend the Government of the United States, to preserve the flag from being lowered in defeat and to always observe the day set aside by the Grand Army of the Republic as Memorial Day, sacred to the memory of the Union Soldiers, Sailors and Marines of 1861 to 1865.
