With sadness, I report the passing of Real Daughter Maggie Devane, of St. Paul, Minnesota on Friday, September 12, 2017 at the age of 111. She is survived by her son Gene Devane, three grandsons, and a niece Doris Bonds. Her husband, Junious Devane and a sister Inez Womack having preceded her in death. Maggie was born on November 17, 1905 to Henry Johnson and Nannie Bell Montgomery, his third wife. Her father was a former slave from Jackson Mississippi who fought in the Civil War as a USCT and was discharged in 1865 near Louisville, KY.

Commander Doyle also mentioned that he met a lady in his group of flag placers, Lori, who is passionate about the Civil War and the War of 1812. She is a history major and wants to teach American History. We are looking forward to maybe seeing Lori at our 2018 Memorial Day Service at Evergreen Cemetery.

Annual Graves Registration Report from

Camp 18 Graves Registration Officer Michael Emett

I have the honor to report that I was successful in the submission of 630 graves during 2017. The breakdown is as follows:

- Texas 330 graves
- Montana 126 graves
 Miscellaneous states 274 graves;
- 45 Confederate soldiers
- 585 Union soldiers

Of the 585 Union soldiers:

- 61 US Colored Troops (buried in San Antonio National)
- 49 Galvanized Yankees (buried in Custer National)
- 1 BG Charles Terrell
- 6 Medal of Honor recipients; John J. Given, Henry Falcott, James Fagen, John Howard, Simon Suhler, Alquilla Coonrod (CW or IW recipient)

Traveling to San Antonio, Texas, last spring I surveyed 6 cemeteries, the San Antonio National is an obscure cemetery buried amidst several other city cemeteries on the other side of the tracks in San Antonio. I was told that the Fort Sam Houston National has no Civil War burials, so I spent the majority of my times in San Antonio National and was richly rewarded. I am certain that I missed a number of soldiers, but records were scant on many of the soldiers. I did find an adjoining cemetery, a 40-acre plot donated to the Confederate veterans of the war. I photographed the stones, but as yet have not had time to attempt their stories. As well, I found two other cemeteries in the area that were rich with more Confederate burials. These I photographed as well, but have not done any research on them either.

Aside from my travels in Texas, I spent a month on the road documenting various cemeteries and burials along the way. I drove from Montana, through Utah and cross country to Spartanburg, South Carolina and back. My greatest find, aside from sparse burial sites, was a Civil War Medal of Honor which I purchased and added to my collection of CW-GAR memorabilia. I might add that while in Texas I purchased two original Indian War kepis that were in very good condition, one had the original hat brass for the 5th US Infantry. I also picked up a medal from New York commemorating soldiers who had participated in the Battle of Gettysburg.

While back in Montana I decided to reresearch the graves I had visited at Custer National when I researched and entered the members of the 7th Cavalry who had participated in the Civil War and have been rewarded further. I discovered the stones that simply stated "U.S. Vols" belonged to "galvanized Yankees" who enlisted in the 1 US Vol Infantry after taking the Oath of Allegiance at Point Lookout, Maryland. They were shipped West to fight Indians in the Montana and Dakota territories. Along with them I have located a number of others from various Union Army regiments who were sent West as well, but died, mostly in the Dakota territory, but later re-interred at Custer National. The work continues....

In other news, I participated in a Veteran's Day program at a local high school where I spoke to five classes of students regarding our veterans of several wars. Afterwards I was invited to march in the towns Veteran's Day parade. On Pearl Harbor day, I spoke to two different organizations concerning the sacrifices of all Americans during World War II.

I will be accompanying my son, Mike Jr, in February as he presents another Civil War paper to a conference in Albuquerque, New Mexico. We plan to go to the site of the Glorietta Pass battlefield while we are there.

A Happy New Year to the Camp members and a wish for another wonderful year of talking to the dead.
