Camp Brother Soars as an Cagle


On June 10th, it was a particular honor for our Camp and the SUVCW to honor one of our own

The departure of SVC Mark Woolfington (see article page 1) created the need for a Camp Officers meeting held on June 25, 2003. Present were Comdr. Jerry Sayre, JVC Will Tisch, Camp Councilmen Tom Helmantoler & Larry Fillhard, Treasurer Gene Armistead PDC, Secretary Dave Allyn, Quartermaster Bob Lowe PDC.

Several urgent matters required immediate attention: the positions of SVC and JVC, Newsletter, Secretary and retention, comfort & involvement of new members.

Per SUVCW Constitution & Regulations, the Camp Council approved Dave Allyn as SVC upon transfer of Mark Woolfington. At his request, Bro. Will Tisch will remain JVC. PDC Gene Armistead was approved as Secretary by the Council. The above

elective positions are interim until normal Camp elections take place in December.

Cagle Scout Certificate Program by Wayne Rogers

We have had unique Eagle Scout Courts of Honor presentations this year. One was for a brother and sister (Girl Scouts Gold Award equal to BSA Eagle rank), and another for two brothers. Both brothers went beyond the Eagle and supplemented it with palms (for additional merit badges and service time). Our latest court of honor, was for an Eagle Scout with 44 merit badges, which is more than double what is required for the highest Boy Scout award.

Our presentations have been well received and applauded. We often have people from the audience indicating how grateful they are that we have made our presentation. I sensed an aura of patriotism in the air. It has been an exciting and enthusiastic program and wonderful to see the response and participation of various members. Additionally, we have coordinated a couple of courts of honor presentations with uniformed personnel from our camp

Since January 2003, we have processed more than 60 Eagle Scout certificates. Out of those, nearly half (28) have been presented in pe con. Because of my residence, I have been able to make presentations as far north as Temecula, California.

San Diggo's Last Union Veteran - by Tom Stinson

San Diego's last surviving Civil War veteran was Thomas Chapmen Shelly, who died Sept. 23, 1943 - 3 months short of his 100th birthday. Shelly was born on December 27, 1847 at Richmond, Ohio, When the War began, he joined the 17th Illinois Infantry and eventually rose to the rank of Captain. During the war, he participated in the Battle of Shiloh and the siege of Vicksburg.

Captain Shelly came to California about 1874 and to San Diego about 1913, where he resided in the 4100 block of 54th Street. He was a member of the Datus E. Coon Post 172 of the GAR. He was an avid player of Chinese Checkers in his elder years. He died at home and was afterwards cremated with the disposition of his ashes unknown to the writer.

After Pearl Harbor began U.S. involvement in World


War II, he counseled depressed visitors at his subsequent birthday party not to worry, saying that "The United States has been in far greater danger. Surely, if we pulled the country through the horrors of a terrible Civil War, the younger Americans that we old soldiers have turned the country over to can bring it through the present crisis". He felt that the situation called for thought, work and action.

At the time of his death, Capt. Shelly and his family believed him to be the last known surviving Union Civil War officer. If true, then he would have also been the last surviving Civil War officer. The last Confederate officer, Captain Holland Bell of the 41st Alabama Infantry, had died five months earlier on April 13, 1943 in Fayette County Alabama.

Multi-Camp Pienie at Huntington Beach Planned

"Civil War Days" at Huntington Beach's Central Park are scheduled for August 30-31, 2003. Two reenactment battles eachday, sutlers, period music, living history demonstrations, food and visiting Union & Confederate Camps make for a wonderful day with family and friends.

Announcement of a multi-Camp picnic and a brief history of our ancestor's GAR summer events was received from Glen Roosevelt, Commander of the newly formed Sedgwick-Granger Camp 17.

Glen wrote, "From 1888 to at least 1937 the GAR and Allied Orders, under the auspices of The Southern California Veterans Association, held at least 50 annual outdoor tent camping encampments on the bluffs of Huntington Beach, on the beach at Coronado, the beach of Ventura, Santa Barbara, Santa Monica, Anaheim Landing, San Diego, Long Beach, and Pacific Palisades. These annual enclaves brought together all the GAR Posts in Southern California for meetings of fellowship (and womanship) and sharing that included the veterans' entire families.

The encampments of 1905 - 1923 were held in a tent camp surrounding the Methodist Auditorium in Huntington Beach (see photo above). Since a great number of us are already likely to be at the Central Park (a great location) reenactment at Huntington Beach on Labor Day

weekend. I recommend that we conduct the First Annual Modern SUVCW Family Picnic at the Camp 2/17/21 display set-up at Central Park on the afternoon of Sunday, August 31, 2003. The battles on Sunday tend to run and end a little earlier than on Saturday, and the crowd of spectators tends to thin out right after the afternoon battle, we could spend a nice afternoon of lingering sun to get together and fraternally commune with our Brothers. Then we have all day Monday to relax and recover from the weekend and from our journeys.

I further recommend that we rotate the annual family, event in conjunction with such events as the Vista or Gaujome reenactments in San Diego County, and the Moorpark reenactment (or other event) up north.

As for this year, I humbly request that you present your Camps with the Huntington Beach proposal for a quick answer for this year's consideration. New Camp 17 will absolutely support a south or north rotated location for next year and the following."

At our June Camp meeting, nine Brothers indicated their intention to attend the Sunday picnic. It has not yet been decided whether it will be a "potluck" or "take-out" food will be provided at cost. You may obtain details, directions, etc. from Comdr. Jerry Sayre or Dave Allyn. Please consider taking part in re-establishing a tradition of the past and let us know how many will be attending.

Treasurer's report. Bob Lowe reported for Gene Armistead; current balance is \$908.89. Newsletter bill is

outstanding. Gene suggests no unnecessary spending until more dues arrive.

Motion (unknown/second by Bob Lowe) to approve the minutes of the April meeting be accepted as published in the May newsletter passed.

Bob Lowe reported on correspondence received: thank you card from Veterans Museum & Memorial Center, SD for the Civil War "cooking pot" donated by JVC Will Tisch. Rosemary Lowe, sent a thank you for the camp's donation to the National Patriotic Instructor's fund of ASUVCW. Dave Allyn reported that Bob Lowe has received recognition (for the 5th year in a row) for recruiting at least 3 new members in the past 12 months.

Pittenger) served in the 2nd OH Inf. He moved that they be considered initiated as of the dates their applications were received, second unknown; passed. Mike Schooling reported on the Memorial Day event at Mt. Hope Cemetery, SD.

Bob Lowe reminded us that we decided against holding a joint meeting with Camp 2; a suggestion has been made by members of Camp 2 that we hold a combined event, a picnic, on Sunday August 31, at the Huntington Beach reenactment. A show of hands indicated interest is good for this.

Bob Lowe reported that a new law was signed by Pres. Bush protecting federal veteran's monuments from vandalism, fines up to \$10,000 and prison terms are among the penalties. CA Assembly bill 207 (now being debated) would similarly protect monuments within the state.

SVC Mark Woolfington reported on the Memorial Battlefield Trees available for sale from a company advertising in Civil War Times Illustrated.

July 4th is the Huntington Beach annual parade at 10 AM. On May 17th SVR Co. G, 5th Calif, marched in the 44th annual Armed Forces Day Parade in Torrance. 11 members were present.

Bob Lowe displayed our new blue/gold/white silk parade banner for the unit. The cost was \$150: contact Dave

Allyn if interested in donating to defray the expense.

Members minutes. Tom Helmantoler is planning to visit his ancestor's battlefields. Colin McKim will celebrate his birthday tomorrow. Brian Bingham shared his copy of the Michigan Cavalry Brigade history. John May has done research on his G-G-G-father's unit. He has his ancestor's GAR badge but needs to have it re-ribboned. Chuck Rothlauf visited Brewer, Maine where they have recreated a small "Little Roundtop." There is a new monument to Joshua Chamberlain at Bowdoin College. Dave Allyn recalled his ancestor's service in "The Iron Brigade of the West." Ernie Powell is taking his granddaughter East to visit historic sites. Mike Schooling announced he is now officially retired! (a round of applause followed) Kim Sayre shared her feelings about attending various Eagle Scout Courts of Honor; how outstanding it is to witness these ceremonies. Each is different and all are meaningful to attend. She highly commends members would all enjoy taking part in these events.

SVC Mark Woolfington conducted the book raffle, which earned \$48.

Let's show National what our Department can do. Our success in this matter will also be an indication of what can be done nationally, when this resolution is addressed at our National Encampment in Ft. Mitchell, Kentucky this August.

BACKGROUND - Fifty-seven years have passed since Bob Hope first entertained our country's men and women in uniform. Whenever there was a need, Bob Hope was there. Thanks to him, hundreds of thousands of soldiers, sailors, airmen and marines have had their spirits lifted.

The United States Congress has honored Bob five times. But, in October 1997, Bob received one of his greatest tributes when Resolution 75 was unanimously passed by members of both houses making him an Honorary Veteran - the first individual so honored in the history of the United States. He was feted in the US Capitol Rotunda by members of congress, military personnel and veterans.

One hundred years old and still making a difference. That's Bob Hope. Now it's our turn to make a difference in honoring this legendary man. Currently, Taffy III is raising funds to create a Military Tribute to Bob Hope in recognition of his efforts for all our country's servicemen and women.

Taffy III is a group of World War II Navy veterans who served on three ships that were sunk during the Battle for Leyte Gulf on October 25, 1944. ("Taffy III" was the code name of this task unit.) In recent years, these men have devoted their efforts toward raising money for monuments to preserve the history of this era. In the past several years they have successfully erected and dedicated four monuments, 3 of which are located at Rosecrans National Cemetery in San Diego.

The Port of San Diego has graciously donated .75 acres on the shoreline of San Diego Bay for this tribute. This property is worth approximately 5 million dollars.

One of the hardest obstacles to overcome was the agreement of Bob, his wife Delores and daughter Linda to erect this Military Tribute. After 14 months of communications and meetings, agreement was reached with certain conditions — money raised for this project would come from the Veterans themselves and the American people. It was further agreed that corporate money would not be solicited and neither his former corporate sponsors nor professional friends be approached for funds. Completion of this "tribute" requires the raising of 4.5 million additional dollars


