Camp Commanders Corner ~ by Tom Helmantoler

Brothers and Friends: Happy New Year to all and welcome to SUVCW, 2008. In addition to the regular activities we have, let us remember an old quote: "The only thing permanent in life is change." With that in mind, as I begin my time as your Commander, the first order of business is finding a place to hold our meetings, which

includes both sufficient size, plus the necessary facilities to have our programs, at a nominal cost. Taking the last point first, many of you already know that our use of the NCO Club at MCAS Miramar is no longer available. This is due to the fact that the facility is to be demolished (if it hasn't been already!) in order to rebuild a newer, nicer facility. Due to the usual budget haggling in Washington, DC, the money to accomplish all this has yet to occur, according to SVC Jeff Malone, who has been investigating this. Therefore, Jeff and I looked at three other facilities, and concluded, for the time being, that our best option at present is the Coco's Restaurant in Clairemont, where we had our December meet-

ing. The main things we considered were size and cost. The, literally, bottom line, is that no place at present is FREE! This place offered the best situation, including central location, for the best price. We will need to guarantee them a minimum of \$100 in dinner purchases

each time we meet there. This won't be difficult, I believe, based on what we spent there in December, which was over twice that amount, with a small turnout for the meeting. In addition, Jeff and I concluded that the room can easily be reorganized for a meeting, and then redone after the meeting for dinner without much effort so that the

room will have more of a "meeting" setting. Jeff will also be investigating menu options, too. I also mentioned to the manager that we would want dinner NOT to be served until the meeting had concluded. It may not be the best situation, but it will do for the time being. Beggars can't be choosers, and I wish we had a facility like the one I visited in Peoria, IL, which is the old GAR Hall there. We're not that lucky. This also doesn't mean we have to be at Coco's for any specified amount of time. If anyone finds a better situation, please run it by Jeff and/or myself and we'll explore it as well. I hope this takes care of our most immediate problem. The next meet-

The Department of California and Pacific is proud to announce the 122nd Annual Encampment, to be held on March 14-15, 2008, at the NCO Club, Camp San Luis Obispo. We are honored to be joined by National Commander in Chief, Charles E. Kuhn, Jr., who will be in attendance. Camp San Luis Obispo is "the original home of the California National Guard." Established in 1928 as a California Army National Guard training camp, it originally totaled 5,800 acres and was known as Camp Merriam. Here is a link to their website:

The National Guard requires that a Vehicle Registration form is completed and presented at the time of arrival at the base. A copy has been attached for your convenience. On Friday, we will have a short, late-afternoon work party at the GAR plot (Odd Fellow's Cemetery), to "spruce up" the cannon and plaque in honor of Ed Strobridge and in preparation for Saturday's memorial service. On Friday evening, we will have our traditional "campfire" gathering at the NCO club. A catered tri-tip and chicken BBQ dinner will be available for those who are interested. The cost of Friday's dinner is \$25 per person. PLEASE NOTE THAT THE OPTIONAL DINNER IS OFFERED AS A CONVENIENCE TO THOSE IN ATTEN-DANCE AND IS NOT MANDATORY FOR ATTENDANCE/PARTICIPATION AT THE "CAMPFIRE." On Saturday morning, we will have our business meeting at the NCO Club. The cost of the Encampment has increased by \$5 to \$30 per member, which includes a delistyle buffet lunch, as well as the ususal accouterments of the day (lunch for guests is \$20). At the completion of the business meeting, we will have our memorial service at the Odd Fellow's Cemetery (7 miles, approximately 11 minutes travel time...see attached map). The Saturday CinC dinner will be held at the NCO club. There is no increase over last years cost and remains at \$30 per attendee. The tentative menu is as follows: Mixed Green salad with Diced Pears, Gorgonzola, and Toasted Almonds; Line Carved New York Steak; Lemon-Caper Chicken Breast; Roasted Onion and Garlic mashed Potatoes; Fresh Squash medley; Rolls and Butter; Dessert. A Little History Lesson on Valentine's Day in the Mid 19th Century

Valentine's Day is upon us. I thought it might be of interest to find information about the impact it had during our era of interest. The following was excerpted from the InterNet at: http://www.linguatics.com/StValentine.html

During the Civil War in the States between the North and the South, many a lonely, crestfallen soldier had Valentines made with a heart split in two, reflecting their loved one's absence and their longing for home. For troops encamped in tents, flaps were made onto the Valentine to reveal a soldier inside (the tent) awaiting his sweetheart with open arms. This became the window Valentine. During times of peace, the window opened instead into a church with a smiling bride and groom within! Another Civil War novelty Valentine, circa 1862, included a real lock of hair from the distant girlfriend,


which the military man proudly treasured and shared with his fellow soldiers. Other Valentines to have survived the Civil War were the paper doll variety and elaborate white lace embroideries. Then, Puzzle Purses appeared on the Valentine's Day scene: They were square envelopes, the four flaps of which were folded one inside the other. Each flap was doubled over and oftentimes artistically decorated on both sides. Many times the puzzle contained a ring, a piece of jewelry, or even a lock of the lover's hair within. When the contented receiver opened this type of Valentine, the trick was not only to be able to read the messages in their correct order, but also to fold all of the flaps back up correctly too! Then, late during Queen Victoria's reign, an Englishwoman named Kate Greenway began to design beautifully artistic Valentines, eventually evolving into a career in writing children's books


for her. Yet it was to be another

fellow countryman named Walter Crane who would rival her in design and uniqueness as well with his colorfully outstanding Valentines. Kate Greenway had sold her first Valentine design for U.S. \$15.00 when she was only twenty-two years of age by selling over 25,000 copies within the first month of their distribution! Yet the cost of British postage remained high, thus preventing trans-Atlantic Valentines from becoming a yearly ritual. But today, both Greenway and Crane's Valentines are true collector's items that carry hefty investment price tags. Then in 1848, precisely on the other side of the Atlantic Ocean, an Esther Howland of Worcester, Massachusetts, while working in her father's stationery store, became intrigued with some beautifully laced white and pink

English Valentines that her father had imported from overseas. Esther, having fallen 'in love' with them, cut out some red paper and pasted some lacy designs onto the sheets thus creating a kind of envelope. She then attached some pictures, penciled in her own artwork, and before too very long she had developed some rather handsome Valentines. She then finished them off with yellow flowers adorned in crêpe paper. Her father was so taken aback with his daughter's artistic skill that he deliberately ordered more pink, red, and white lace paper, some more crêpe paper, more ink bottles and fountain pens, and some specially designed paper flowers for further ideas. Esther continued on with her Valentine-inspired endeavors and, as Fate would have it, her brother who traveled in his horse and buggy advertising and selling for his father's stationery business requested of her if he could take along with

him any extra Valentines she had made that she wouldn't mind parting with. Thinking along the lines of maybe earning U.S. \$100-\$250, Esther was stunned beyond belief when her brother returned with orders of up to U.S. \$5,000-\$6,000! Once the supply of paper her father had ordered finally arrived from England, Esther hired some of her girlfriends to assist her with the drawing and copying of Valentine designs that she would drum up. She set up an assembly line wherein one young lady would paste the background, another would glue the lace, and yet another would cut out the pictures, thus completing an amply full Valentine by the end of the "line". As orders increased with alacrity, Esther hired more women and, before too very long, her "factory of Valentines" grew so much that she had to move out to larger and more profitable quarters. By 1862, one New York card com-



Unusual Original Item Donated to Camp

Pat, a friend of Cindy Hodges, found this unusual item in her attic and doesn't believe it is an item from her family. She donated it to our Camp and it will be on display at our next meeting. At that time, we will discuss options. It is printed on some kind of fiber board. Framed like a photograph, it is roughly 3 feet high by 2 feet wide. The text of the central panel reads, "Know ye that Seymour H. Hogle enlisted from Coldwater, Branch County, Mich. Jan 20, 1862 and was mustered into the U. S. service at Detroit, Mich. 10. as a private of Co. M. 5th Regt. Mich. Vol. Cavalry under Capt. F. A. Copeland and Col. Joseph F. Copeland to serve three years or during the war. He was honorably discharged June 15, 62 at Detroit, Mich on account of disability. He re-enlisted Jan. 2, 63, as a private in Batt. C. 1st Regt, Mich. Vol. Light Artillery, under Capt. Geo. Robinson and Col. Cyrus O. Loomis to serve three years or during the war. The Regt was assigned to the Army of the Tennessee. Said Seymour Hogle. took part in battles at Decatur, Ala. Resaca, Ga. Dallas, Ga. Big Shanty, Ga. Kenesaw Mt. Ga. Nickajack Creek, Ga. Chattahoochie River, Peach Tree Creek, Siege of

Atlanta, Ezra Church, Jonesboro, Lovejoy Station, Snake Creek Gap, March to the Sea, Savannah, Ft. McAlister, Campaign of the Carolinas including Pocotaligo, S. C. Comtahee River, Orangeburg, Cheraw, Fayatteville, N. C. Bentonville and Raleigh including Lee's surrender. Also took part in Grand Review at Washington D. C. May 24, 1865. He was wounded in hand by a piece of shell. Was rendered blind for some time and his shoulder paralyzzed by a cannon ball passing close to his head. He was at Decatur, Ala. and Atlanta, Ga. building fortifications. Received his Final Discharge June 21, 1865 by reason of close of the war at Detroit, Mich" Below the main panel a smaller panel reads, "This picture of the (illegible) Monument bearing the Personal Army Record of Seymour Hogle was presented by him June 1st 96 to his wife Belle and dedicated to his son Clifford as a tribute to loyalty." check of the InterNet for "Seymour Hogle" reveals he was born in 1845, was age 19 when he re-enlisted in the 1st Mich Light and is buried at Burr Oak Cemetery, St. Joseph County, MI, having reported to The Final Muster in 1929.
