various Officers both past and present, but I feel we need to begin to assemble them in a concise manner.

Through the efforts of Camp 18 Commander, Richard Burns and Camp Sec/Tres Rudy Velasco, these were returned to Camp 4. A few years ago, the Department needed to buy back our banners and original Charter that had been lost because it was in the trunk of a car of a Brother who died and the car was sold to someone in Reno, NV.

This can happen all too easily, we must begin this effort now.

#### Historic Pittenger House dedication on March 31 By Cecelia Njust, Special to the Village News

The Fallbrook Historical Society (FHS) will host the Monserate Chapter of the National Society of the Daughters of the American Revolution's (DAR) dedication ceremony of Civil War hero William Pittenger's restored farmhouse at the FHS museum on Saturday, March 31. A plaque will be placed on the building during the event, opening with the uniformed Color Guard of the Sgt. Pittenger Camp, Sons of the Union Army.

DAR chapter Regent Beverlee Stuart-Borok will introduce

the dignitaries including Dr. Bradley Resare, pastor of the United Methodist Church of Fallbrook. Pittenger had been an early minister of the Fallbrook Methodist-Episcopal Church, which was located at the time on East Elder Street at South Mission. Across Elder to the north is the house that was the Pittenger home in town.

The exacting process of naming the Fallbrook site as historically significant has taken more than a year of DAR chapter work for Washington D.C. NSDAR's approval. Built in 1895 by Pittenger, the provenance from that time to the present had to be thorough and presented with the reason for the site selection.

Sgt. Pittenger took part in the Andrews raid into Georgia to destroy train tracks that allowed Confederate supplies into the border states and beyond. The raid was not a success although it became famous in books and movies. Some of the captured men survived and were awarded with a Medal of Honor authorized by Congress. President Abraham Lincoln presented the men with swords, one of which is part of a private collection in Fallbrook. Pittenger's grave in the Fallbrook Pioneer Cemetery is marked by a Medal of Honor stone.

The plaque unveiling will start at 10 a.m. with refreshments to follow. Docents will welcome special guests and the public to the museum grounds and exhibits. For more information, call (760) 728-3271.

William Pittenger Camp No. 21 participated in the dedication of an historical marker at the Pittenger House in Fallbrook. Sgt. William Pittenger served with Company G, 2d Ohio Infantry. He was awarded the Medal of Honor for his service in Georgia, April 1862, where he participated in the "Andrews Raid". Pittenger authored "Daring and Suffering: A History of the Great Railroad Adventure", published in 1887. Hollywood adapted the book twice, with "The General" in 1927 (Buster Keaton) and "The Great Locomotive Chase" in 1956 (Walt Disney).

# SONS TO ESCORT FATHERS TODAY ING. A. R. PARADE

U. S. Grant Camp of San Diego to Be in Line Just After Grand Marshal.

The Sons of U.S. Veterans, 50 or more strong, will be the official escort to their fathers today in the big parade of the Grand Army of the Republic, which is to be the feature of the encampment being held in San Diego this week.

Led by U. S. Grant Smith, commander of the local chapter, U. S. Grant Camp No. 37, the sons will be in line just after the grand marshal and his aides and just preceding the veterans. At the stadium they will take position at one side of the Grand Army men for the review.

#### G. A. R. SUCCESSORS

The Sons of Veterans are destined to be the successors of the G. A. R. and carry on the work of patriotic teaching and love of flag and nation that their fathers fought for. They are entitled to sit in the sessions of the Grand Army.

Although small in size compared with some of the organizations allied with the G. A. R., the Sons of Veterans at this encampment have devoted themselves seriously to business and are holding long and strenuous sessions. Tonight a class of five or more San Diegans who have just joined the order will be iniated at a meeting in Masonic Temple by the drill team of the Past Commanders' club of Southern California. Among the candidates are C. H. Terwilliger. Leslie G. Zeigler, Harvey N. Jackson, James S. Gipson and Frank L. Cramer.

#### ONLY ONE CANDIDATE

C. O. Boynton of Long Beach, who was elected yesterday as division commander to succeed W. A. Thayer of Santa Barbara, was the only candidate for the post. Death eliminated one candidate in Fred C. Martin of Los Angeles, whied a few weeks ago.

In this connection an affecting scene happened yesterday when Martin's father, who was one of the delegation which brought greeting to the Sons from the G. A. R., attempted to address the meeting and was so affected by grief that he broke down. L. A. Ludwig of Santa Ana, division counsellor, was another prominent member called by death recently.

Beth Wanda of Sawtelle, affectionately known among the Sons as "Mother" Wanda, because of the interest she has taken in their order, addressed the meeting and was given an ovation.

The Sons will end their convention tomorrow.



From the Evening Tribune, San Diego Ca., Thursday, August 5, 1926, Page 5: PIONEER CITIZEN OF S. D. SUCCUMBS

Following an illness that had lasted some time, M. D. Hamilton, a pioneer resident of San Diego, died last night at the navy hospital.

Hamilton, who at one time was active in the civic affairs of the city, leaves a widow, one son, Hugh Hamilton, and two daughters, Mrs. Maud Spencer and Mrs. Ole Lemon, all of San Diego. Funeral arrangements will be announced later. The body is at Bradley-Woolman undertaking establishment.

From the San Diego Union, Ca., Saturday, August 7, 1926, Page 5:

# **My Union Ancestor**

# My Union Ancestor

Peter Hardman Babcock was born in 1841, in Salem Township Shelby County, Ohio, to Deacon John Babcock and Elizabeth Hardman Babcock. He was the younger brother to my Great Great Grandmother, Margaret Babcock Sayre. Little is known of his childhood other than he moved from Ohio, to Iowa, with my Great Great Grandparents.

At twenty years old, on 05 September of 1861, he mustered into Co A, 8th Iowa Infantry Volunteers for a term of 3 years, during which he served as a Private. In March of 1862, the 8th moved from Sedalia to St Louis; then to Pittsburg Landing and the battle of Shiloh. During the battle in April of 1862, the 8th Iowa was positioned to defend an Artillery Battery. The Battery got away, but most of the regiment was captured. The enlisted of the regiment were confined at Macon, GA, until October of 1862 when he was paroled and officially exchanged on November 10th.

December of '62 regiment was reorganized at Davenport, IA, and stayed there until January of 1863. They served in Rolla, MO until April of '63, when the regiment was ordered to Young's Point, LA as part of the Vicksburg Campaign. It was at this time that Peter became ill, and died of his disease on the 8th of May, 1863 at Duckport, LA.

Duckport, LA is not on any current map of the US, as the Mississippi moved and consumed it after the war. All that remains today, is a depression where Union troops tried to dig a canal to bypass Vicksburg during the spring and summer of "63, called Duckport Canal.
