Sunday, we continued a tradition begun by our beloved, late brother, Bob Lowe, providing a color guard and musket salute for the 1812 Elk's Lodge at the El Cajon Cemetery. As in the past, brothers enjoyed visiting with Rosemary Lowe following the ceremony. The management of the cemetery had very nice refreshments set up for all attendees. On Monday morning, brothers Tisch, Ernie Powell (in 'Gray') and Jerry Sayre, PDC participated in ceremonies at Rosecrans National Cemetery. In the afternoon we held our customary services at Mt. Hope's Hill. Along with "Confederate Cousins" of the SCV, and members of the DUVCW, Auxiliary to SUVCW, UDC and SD Civil

War Roundtable, what we have come to call the "San Diego Civil War Community," we conducted a service honoring Winfield Scott, Chaplain U.S.A. We were honored to present two National Flags to descendants of Chaplain Scott. Commander Deane MC'd the event admirably, SD Opera star, Rita Cartwright, sang beautifully as did our own, Ernie Powell. Barbara Mondt, DUVCW, delivered a well-researched recap of Chaplain

Scott's service and life. We also heard from the two recipients of the award for best essay on "The Importance of Memorial Day." A special thanks to San Diego Mayor, Bob Filner and staff for his attendance and "a few appropriate remarks" on the need to attend to our veteran's often deplorable living conditions. Thanks go to the Miramar Young Marines for providing a color guard and handling the Flag-folding honors. After completing our ceremonies, some of us enjoyed dinner at the Black Angus. Additionally, Bro John May, Sec/Treas had the honor to read Gen. Logan's Order #11 at the

ceremony held in Oceanside at the Veterans Assoc. of North County. My apologies to any other brothers who may have participated in their own local Memorial Day events—about which I have not received word. It is our Order's highest calling to remember the "Boys in Blue" in annual ceremonies wherever we find ourselves. General Order # 27 (SERIES 2012 -2013) 25 July 2013

1. The proposed Amendment to the SUVCW Constitution to Change the Preamble to Reflect Revenue Cutter Service as Eligibility for Membership has passed. The vote so far is 23 Department reporting with 494 Yeas, 18 Nays and 5 Abs. There were 19 Departments that voted unanimous for approval.

Singing by both Rita Cartwright and Ernie Powell was excellent. Brother Sayre did an excellent job as well, leading the musket fire. The only problem was the Miramar Young Marines who had difficulty folding the flag correctly and it took much too long. Afterward, several couples enjoyed dinner at the Black Angus Restaurant in Mission Gorge. Mrs. Cartwright has been paid for her performance.

Mortar Renewal: It has taken two years, but is nearing completion. It is at the SD Aerospace Museum Restoration facility at Gillespie Field. The Camp agreed to allow Will Tisch to buy 60 bolts and nuts to finish it, and the Camp will reimburse him for them. Bro. Report of Activities by Tom Helmantoler, PCC

A busy spring was achieved by Brother Tom Helmantoler, PCC, being involved in five different activities to promote the activities of the Camp and furthering knowledge of the Civil War.

In May, he performed his program, showing his three replica Civil War uniforms, including infantry, cavalry and staff officer infantry uniforms, leather set, and great coat. No weapons were shown, but a few relic bullets and his gr-gr grandfather's medal from West Virginia were displayed. His ancestor served in the 18th Ohio Infantry and 2nd West Virginia Cavalry from April, 186l, to November 1864. He was one of President Lincoln's original 75,000 volunteers, having enlisted on April 17, 1861.

The uniform program was presented to Mrs. Renee Thomas' 8th grade US History classes at Marston Middle School in Clairemont and to Commander Rick Jordan's NJROTC classes at Westview High School in Carmel Valley.

On June 1, Tom presented a talk on, "Long and Short Term Results of the Civil War " to his former California State Military Reserve unit at the Joint Forces Training Base, Los Alamitos, Orange County, CA. He served in that unit for five and one half years.

Also in June, Tom presented JROTC medals and certificates, on behalf of Camp 21, to cadets at the Air Force unit at Mira Mesa High School and the Navy unit at Westview High School. Both programs were very enjoyable and both are excellent units.

This Day In Civil War History

Saturday July 27 1861 MCCLELLAN MAKES MANASSAS MOVEMENT

George McClellan achieved the goal today for which he had struggled, connived and exerted every bit of political leverage he could muster. No, it had nothing to do with contact with the Confederates, the struggle was to get to the top of the military heap, which in these days was command of the Army of the Potomac. His commander in chief expanded on a memo he had written right after the debacle of the Battle of Manassas. Detailing the moves which should be made to put down the rebellion as quickly as possible, he suggested Union moves on Manassas Junction and Strasburg in Virginia, Memphis to be attacked from Cairo, II., and a move from Cincinnati on east Tennessee. As the supposedly neutral Kentucky stood in the way of the latter, there would prove to be difficulties.

Sunday July 27 1862 TOONE'S TRIBULATIONS TROUBLE TENNESSEE

It was yet another day of minor skirmishes here and there, but no preparation for, recovery from, or conduct of major battles or operations. Some of these were in connection with what was known as "operations"--more than an exploration but less than a planned battle. One such proceeded from Rienzi to Ripley, Miss.; another one went for a couple of days between Woodville to Guntersville, Ala. One action big enough to be classified as at least a "skirmish" took place at Toone's Station (also known as Lower Post Ferry), Tennessee.

Monday July 27 1863 YANCEY YIELDS YANKEE YOKE

William Lowndes Yancey died this day in Montgomery, Alabama, a frustrated man. His history is interesting: he was Southern born. After his father died his mother remarried an avid abolitionist and the family moved to New York. Yancey lived there until he was a student at Williams College in Massachusetts when he abruptly dropped out and moved back South to read law under an old friend of his father. He was an orator of some note, and so devoted to the South that he was advocating secession years before the events of Ft. Sumter actually occurred. His ambition was always to be President of a Southern Confederacy, but he was too radical even for them and was passed over in favor of Jefferson Davis. He spent the war years in a "loyal opposition" working to restrain even what limited powers Davis had.

Wednesday July 27 1864 HOOKER, HUFFY, HASTENS HIBERNATION

It was a game of musical chairs at the headquarters of the Union Army of the Tennessee to-day. Gen. John "Black Jack" Logan, head of this force, had compiled a solid record for a man with no military training whatsoever, and was going to accompany William T. Sherman to Atlanta and beyond. This left the army command open and today this prize went to Oliver O. Howard, who was compiling a much better record in the West than he had with the 11th Corps of the Army of the Potomac in the East. The one with his nose most out of joint was Gen. Joseph "Fighting Joe" Hooker, who got his nickname from a newspaper typo rather than any battlefield accomplishment. Hooker, currently a corps commander, felt that since his commission predated Howards', he should get the job. He was in fact in such a snit that he quit the army altogether.
