Jerry Sayre reports he has a new member pending signature and dues

Motion to accept Minutes of last meeting made by Jerry Sayre, second Will Tisch – passed

Chaplain Dave Allyn reports no correspondence

Secretary/Treasurer John May absent – no Treasurer's report CC Deane Poole reports checks totaling \$100 have been sent to the essay contest winner and Mrs. Rita Cartwright for their presentations at Mt. Hope, Memorial Day

Old Business:

Dave Allyn reports on the poster given to the Camp by Cindy Hodges (Seymour H. Hogle, Easel Monument Foundation, framed) as a possible fundraiser which the Camp originally commissioned Dave to locate descendants but he has not been able to find any. Dept. of Michigan's Keith Harrison PCinC is President of the GAR Museum in Eaton Rapids, MI and offered to take the poster to display same there. Dave suggests the Camp approve shipping the poster to this museum where it will be on display. Motion – Dave Allyn – in lieu of not finding descendants of Mr. Hogle, we donate the poster to the GAR Museum in Eaton Rapids, MI, Second – Jerry Sayre, passed. CC Deane asked Will Tisch to make a certificate to give to the museum to recognize Camp 21 as the donor. Shipping is difficult so need to mail by UPS. Motion – Jerry Sayre – to authorize \$50 for costs up to \$75 for packaging/insurance by UPS, Second – Tony Moffitt, passed. Dave Allyn will put photo/info of the poster in newsletter.

Dave Allyn reported on Memorial Day events at Fallbrook, Mt. Hope and Kim Sayre shared Fallbrook newspaper article/photo – We looked great! Also spoke about John May participating in the N. County Vets Association event in Oceanside and event at Ft. Rosecrans. Mt Hope was well represented by many organizations. SCV hosted the event. CC Deane declared Camp 21 did an outstanding job!

Jerry Sayre announced he is taking orders for the attractive plastic badges (Camp = blue, Dept = red) cost = \$12 interested brothers contact Jerry.

Will Tisch spoke about cleaning up the mortar again and repainting because of rust. Wants to put posts with thick chains around the mortar. Mortar is in good shape now – just needs to

be greased. Decision was for caulking the seal vs. grease. Motion to reimburse Will for supplies made by Jerry Sayre, second – Tony Moffitt, passed.

Jerry said on Memorial Day a gentleman came up and said that the Masons were the ones that restored the mortar – not SU-VCW; Jerry thinks we need to get a plaque stating Camp 21 restored the mortar. Will passed around photos of the mortar and chain. Will is going to speak to the Cemetery about putting up pasts and a chain around the mortar. CC Deane Poole brought up the rumor that Mt. Hope Cemetery will not give us shade, podium or chairs for free and the Camp can provide our own if necessary.

Jerry Sayre announced a living history event at Ft. MacArthur, 12-13 July

Concluded business meeting at approximately 6:00 followed by a presentation by Bro. John Finch on "Using Genealogy to Identify your Civil War Ancestor."



This Day In The Civil War

Wednesday July 31 1861

MISSOURI MAKES MOMENTOUS MOVE

Missouri, as both a border state and a Western one, could have easily gone either way as a Confederate or Union ally. Legally elected Gov. Claiborne Jackson had endeavored to speed up the process by simply declaring the state for secession. Thanks to Gen. Nathaniel Lyon and Francis Blair Jr., Jackson was no longer governor but a refugee with Confederate forces in Arkansas. A new convention wa hastily held and Hamilton R. Gamble was inaugurated as his replacement. He made a patriotic speech.

Thursday July 31 1862

POPE'S POLICY PROVOKES PETULANCE

Negotiations had been underway for some time to work out a formal agreement, or cartel, for the exchange of prisoners. Jefferson Davis wrote to Robert E. Lee that the agreement was in place: with one exception. Gen. John "One pinch of owl dung" Pope had recently issued orders punishing Virginia citizens for depredations committed by Confederate soldiers on his Army of Virginia, and threatening to shoot any civilians caught crossing the lines. Davis told Lee that any prisoners taken from Pope's forces were to be treated as common criminals, not prisoners of war. Lee used this only rarely.

Friday July 31 1863

RAIDER RACES REACHING REPAIRS

The commerce raiders of the Confederacy, although capturing or sinking relatively little of the commerce directed at Northern ports, had one curious effect: by driving insurance rates so high that they caused owners to re-register their vessels under the flags of other countries, they reduced United States flag shipping to levels that were never restored to this day. One of the fiercest, CSS Florida, was now two days out of Bermuda on course for the repair yards of Brest, France. Her skipper, Commander Maffitt, was ill and had requested that a replacement be sent over.

Sunday July 31 1864

CONFEDERATE CAVALRY CONFLAGRATES CHAMBERSBURG

Gen. Jubal Early's Confederate cavalry had been on an extended raid into the North, attempting to force Lincoln to pull forces away from Grant's siege of Petersburg, Va. He had gone to the gates of Washington and been driven off. He had gone as far as Chambersburg in Pennsylvania, demanded a ransom, and when it was not paid, burned a good part of the city. Today he was suddenly under attack by Gen. Averel's Federal cavalry and headed for Cumberland, Md.

Commemorating the 150th Anniversary of the Siege of Atlanta, the 2014 National Encampment site will be in Marietta, a suburb of Atlanta and the site of Marietta National Cemetery and the Battle of Kennesaw Mountain. This will be the first time a National Encampment of the Allied Orders will be held in Georgia. Encamp-
