Thankfully his home was not in peril, but the highway connecting from the west

had been closed and, at that moment, there was concern as to a shift in wind that could have created a new burn path. It turns out that we did not need to cancel, but I decided on the side of caution and, in other similar circumstances, would conclude the



same.

Regretfully, several persons had invested time and money to prepare for our Christmas meeting and I want to acknowledge Peter, Joyce, Kim and Jerry and others that had prepared to give us the best Camp 21 Christmas meeting ever! Thanks so much for all your work.

Thankfully, no one in our membership was hurt or displaced by this fire. Again, I attribute the work of the Cracker Jack outfit that is CAL FIRE* (formerly known as "CDF") in extinguishing the threat of this fire. The dedication and preparedness of these professionals is outstanding. Thank one when you see them.

Civil War Terms

Havelock: (pronounced *hav-loc*) A white cloth cover that went over a soldier's kepi, and had a long back that covered a soldier's neck and shoulders. **Housewife**: Small sewing kit

soldiers used to repair their garments.

Haversack: Small canvas bag, about one foot square, used to carry a soldier's food. these bags were painted with black tar to make them waterproof.

This Month in The Civil War

January 1861 - Six additional southern states secede from the Union.

January 19, 1862- Battle of Mill Springs, Kentucky. The Union victory weakened the Confederate hold on the state.

December 31-January 3, 1863- <u>Battle of Stones River, Tennessee</u>. Fought between the Union Army of the Cumberland under General William Rosecrans and the Confederate Army of Tennessee under General Braxton Bragg, the costly Union victory frees middle Tennessee from Confederate control and boosts northern morale.

January 1, 1863- The Emancipation Proclamation goes into effect. Applauded by many abolitionists including <u>Frederick Douglass</u>, there are others who feel it does not go far enough to totally abolish slavery.

January 15, 1865- Assault and capture of Fort Fisher, North Carolina. Union occupation of this fort at the mouth of the Cape Fear River closes access to Wilmington, the last southern seaport on the east coast that was open to blockade runners and commercial shipping.

Glass plate photos of civil war some 288 pics the last are all the generals.....

Please read the instructions before viewing...These pictures are very profound. It is fortunate that these photos have survived. Most probably a million wet plate photos were made during the civil war on glass plate.

Popular during the war, they lost their appeal afterwards and so many were sold for the glass. Many used in green houses. Over the years the sun caused the images to disappear.

These are pretty amazing considering they were taken up to 150 years ago: A compendium of photos from era of the War Between the States. Run the cursor over the photograph and the picture caption will pop up.
