Book Review by Brad Schall

History of the Grand Army of the Republic by Robert Burns Beath, originally published in 1899. This is a reproduction of the 1899 book by General Books, New York. I would like to say it is an easy read but it is not; however, it's a very interesting read and if you have a passion for the Order then it is a good read.

I think the introduction says it best.

"I have been asked to write a few prefatory words to the History of the Grand Army of the Republic. That society whose watch-words are Fraternity, Charity and Loyalty. Fraternity so wide-spread as to embrace all who honored themselves by enlisting in the Union Army; a charity so broad as to have included within its benefactions suffers of every class, and of all sections of our country; a Loyalty that maintains 'true allegiance to the United States of America based upon a paramount respect for, and fidelity to, its constitution and its laws, "that discountenances" what ever tends to weaken loyalty, incites to insurrection, treason or rebellion,' and encourages 'the spread of universal liberty, equal rights and justice to all men,' and

which constantly inculcates the spirit of goodwill and friendship for all law abiding citizens of our common country, needs no commendation to the readers of this book."

Comrade Beath ends the preface by saying:

"In closing this work, I cannot better express my appreciation of this grand fraternity of ours, than by repeating the words used in my address as Commander-in-Chief: "We are enjoying, in a land we helped to save, a companionship made sacred by common sufferings and sacrifices. No other organization on earth can lay claim to such glorious and precious memories. Let us keep this brotherhood together on the highest plane of citizenship and prove to the people, North and South, that the Grand Army of the Republic is worthy of their confidence, that it is doing a work demanded by the strongest claims of humanity, and that its objects are in accord with the purest principles of patriotism."

Grand Army Blue Book 1895

PREAMBLE

We, the soldiers and sailors, and honorably discharged soldiers and sailors, of the Army, Navy, and Marine Corps of the United States. Who have consented to this Union, having aided in maintaining the honor, integrity, and supremacy of the National Government during the late rebellion, do unite to establish a permanent association for the objects hereinafter set forth; and through our National Encampment do ordain and establish the following Rules and Regulation for the government of this association. Page 13, 1895 GAR Blue Book

Chapter 1, Article 2

"The objects to be accomplished by this organization are as follows:

Fraternity

To preserve and strengthen those kind and fraternal feelings which bind together the soldiers, sailors, and marines who united to suppress the late rebellion, and to perpetuate the memory and history of the dead.

Charity

To assist such former comrades in arms as need help and protection, and to extend needful aid to the widows and orphans of those who have fallen.

Loyalty

To maintain true allegiance to the United States of America, based upon a paramount respect for, and fidelity to, its Constitution and laws, to discountenance whatever tends to weaken loyalty. Incites to insurrection, treason, or rebellion, or in any manner impairs the efficiency and permanency of our free institution; and to encourage the spread of universal liberty, equal rights, and justice to all men."



History of Civil First US Sharpshooters War Unit:

Organized September 1861 to December 1864 when they were combined with the second US Sharpshooters The 1st U.S. Sharpshooters was raised as follows:

Companies "A, B, C, D, E, F, G, H, I, K"

Companies "A", "D" and "H" were organized at New York City, New York in September 1861.

Company "B" was organized at Albany, New York in September 1861.

Company "C" in Michigan on August 21, 1861.

Company "E" in New Hampshire on September 9, 1861.

Company "F" in Vermont on September 13, 1861.

Company "G" in Wisconsin on September 19, 1861.

Company "I" in Michigan on March 4, 1862.

Company "K" in Michigan on March 30, 1862.

The 1st and 2nd U.S. Sharpshooters were consolidated on December 31, 1864.
