One must have a book or several by James M. McPherson. Mine are: Battle Cry of Freedom For Cause & Comrades Crossroads of Freedom This Mighty Scourge The Negro's Civil War

Then there are the Edwin C. Bearss books: Receding Tide The Vicksburg Campaign (3 volumes) Fields of Honor

Bruce Catton's Grant Moves South and Grant Takes Command are on the shelf along with Shelby Foote's three volumes on the Civil War.

Then there are those books centered on my Civil War ancestor's experience which included Vicksburg. There are Terrence J. Winschel's two volumes Triumph & Defeat, Vicksburg's Long Shadow by Christopher Waldrep and Champion Hill by Timothy B. Smith, Nothing But Victory by Steven E. Woodworth.

Then there are the more specialized books like the History of the Seventy Third Indiana Volunteers (my wife's ancestor) and The Lightning Mule Brigade by Robert L. Willett.

Of course what started this partial inventory was the GAR. Glorious Contentment is on the shelf with William H. Ward's Records of Member of the Grand Army of the Republic, With A complete Account of the Twentieth National Encampment (1886) which you all recall was held in San Francisco.

Oh, yes, I downloaded Won Cause to my Kindle. Next month I will do a brief review of The State of Jones by Sally Jenkins and John Stauffer.
