

#### Senior Vice-Commander-in-Chief Column SVC Jeffrey Vaillant Grave Markers Article from Dick Eastman Genealogy newsletter

I received the following email message from newsletter reader Lynne Kay Shuffield:

After almost 50 years of lying in all but forgotten unmarked graves, two World War I veterans will finally receive their rightful government headstones after a Court Order is issued by Galveston County Probate Court Judge Kimberly Sullivan, Tuesday, April 8, 2014, 11 am, 600 59th St., Suite 2305, Galveston, Texas, 775571.

The Veteran's Administration initially denied headstones for Privates Frank Ellis and Oscar Juenger, US Army, because they currently have no next of kin. This did not deter a tenaciously dedicated local historian and genealogist, Deborah Gammon, who has, for more than 3 years, been gathering data, doing genealogical research and reconstructing their service records in hopes of officially marking their graves.

After contacting Galveston County 56th District Court Judge Lonnie Cox for help with a Court Order to name her next of kin, Cox arranged for League City attorney Jack Ewing to donate his services to draft and to submit the Court Order to be presented in Probate Court. Once the order is signed, the Veterans Administration has agreed to process the headstone request.

Once both headstones are in place at the Fairview Cemetery, where Ellis and Juenger were buried in 1965, a ceremony honoring the men's service to their country is planned.

The historic Fairview Cemetery is located at the end of Kansas Street in League City, TX. Established in 1900, the 114- year old cemetery holds approximately 1200 residents of League City and several surrounding communities and holds a Texas Historic Cemetery designation.

In 2013, the VA changed its rules/policy and began requiring all veteran headstone applications to come from authorized family or the deceased veteran only, halting efforts from veterans groups to provide headstones to homeless veterans or veterans lacking next of kin.

Under this policy, the VA has stopped accepting veteran headstone applications from anyone except individuals who they recognized as authorized family members or the veteran themselves.

On 16 May 2013, a bill was introduced in the U.S. Congress, H.R. 2018 - Honor Those Who Serve Act, which would amend current VA policy to allow such groups as veteran organizations (VFW or American Legion), military researchers, local historians, and other civic organizations to request headstones on behalf of fallen veterans to ensure a proper military burial.

## Senior Vice-Commander-in-Chief Column SVC Jeffrey Vaillant

Camp Commander's Column—December 2013 (Sorry I didn't do a December newsletter and left this out)

PCinC Brad Schall spoke at the San Francisco Civil War Roundtable about Thaddeus Stevens. The talk combined information from the movie Lincoln in which Tommy Lee Jones portrays Thaddeus Stevens, the internet (<u>http://en.wikipedia.org/wiki/Thaddeus\_Stevens</u>) and Hans L. Trefousse's book Thaddeus Stevens: Nineteenth Century Egalitarian (University of North Carolina Press, Chapel Hill, 1997). Frankly I did not know much about Thaddeus Stevens and Brother Brad's talk whetted my interest. So, it was off to amazon.com after the meeting to purchase the book (<u>http://www.amazon.com/Thaddeus-Stevens-Civil-War-America-ebook/dp/B00AYLHI5U/ref=sr\_1\_1?s=books&ie=UTF8&qid=1386818078&sr=1-1&keywords=thaddeus+stevens</u>).

"The city of York, which became Steven's home in 1815...was the home of...the York Academy, and ungraded school which, needing a teacher, had attracted Stevens in the first place." Thaddeus applied himself to study for admission to the bar which he accomplished in 1816 taking the exam in next door Maryland. He returns to Pennsylvania and Gettysburg where he established his practice. He is elected to the federal House of Representatives and establishes himself in a leadership position. By July 1861 he was the Chairman of Ways and Means. In that role he singlehandedly funded the beginning of the Civil War." A loan bill calling for the issue of up to \$250 million in 7 percent twenty-year bonds, and of temporary treasury notes payable after three years at 7.3 percent, as well as an offer of \$100 million authorized abroad became law—Stevens forced it through with only one hour allowed for debate—and a supplementary measure on August 5 enabled the Secretary of the Treasury to

issue additional bonds at 6 percent. In additions, the committee also asked Congress to legitimize Lincoln's use of unauthorized funds at the beginning of the emergency." (Page 114)

Stevens was a Radical Republican well out in front of many issues. "By the time Congress adjourned in July 1862, Stevens had become one of the best known radicals in Washington as well as in the nation. Constantly agitating for an end to slavery, the enrolment of black troops, a vigorous prosecution of the way, and its financing through legal tender notes, he had become a symbol of change for his countrymen, and his recognized positions of leadership made him one of the most influential members of the House." (Page 124)

"Throughout the Civil War, Stevens had been critical of Lincoln. Considering the president too hesitant and too slow-moving about the abolition of slavery, he failed to appreciate the chief executive's consummate political skill...Both were dedicated to the abolition of slavery and the maintenance of the union, and it was in fact their different ways of approaching their goal that in the end made its realization possible." (Page 150) This was a great book to read and it can best be summarized by the jacket statement that "Trefousse traces Steven's career through its major phases: from his days in the Pennsylvania state legislature, when he antagonized Freemasons, slaveholders and Jacksonian Democrats, to his political involvement during Reconstruction, when he helped author the Fourteenth Amendment and spurred on the passage of the Reconstruction Acts and the impeachment of Andrew Johnson." The book is well sourced with an extensive bibliography.

Currently, the Civil War (1861-1865) is being commemorated by a number of individuals and organizations in the United States. One of the remarkable highlights of the Library of Congress's "The Civil War in America' exhibition, which closed in January 2014, is still freely accessible: The "Voices from the Civil War Blog," (<u>http://blogs.loc.gov/civil-war-voices/</u>), which showcased materials from the physical and online exhibit, and features entries from the personal memoirs, diaries, and letters of those who lived through this turbulent era.

The website is a blog rather than a static site, which means that the entries are organized by the date the item posted on the website rather than chronologically by the original document date that is displayed. The blog can be searched by any keyword in the post or browsed by the author or month and year of the original document.

The entries are transcripts of specific passages from the Library of Congress Manuscript Division and chronicle both Northern and Southern views. These entries are the personal words of people like Walt Whitman, Ulysses S. Grant, Clara Barton, Robert E. Lee, and many others. Clicking on the image provided redirects to the online exhibit which offers an enhanced experience. Further details relating to the individual and document are supplied, along with links to any other materials in that particular set of papers. Each of the images can be enlarged and printed, and for those who have trouble reading the handwritten script, a transcript is also available.

The personal accounts, from those who were directly affected by the War that describe both events and daily life are a bonus for historical and genealogical researchers who seek to learn more about this era. Stories that should be preserved can be found within these papers, such as John Chase's tale of being left for dead following the Battle of Gettysburg. Chase, a recipient of the Medal of Honor, is chronicled in the blog because after losing his right arm and suffering an assortment of other injuries, he won a "left-handed penmanship contest" held by "Soldiers' Friend Newspaper."

As our country continues remembering the War Between the States, take the time to read the words of those who truly experienced our great nation when it was divided. Some examples of these are available on the "Voices from the Civil War Blog."

San Francisco's biggest Memorial Day observance. The 191st U.S. Army Band leads a parade from the Main Post (near Lincoln and Sheridan streets) to San Francisco National Cemetery. There, a formal ceremony (11 am-12 noon) includes music, remarks by military and civilian dignitaries and a 21-gun salute. The National Park Service then leads 30-minute tours of the cemetery.

The cemetery in the Presidio is an official National Historic Landmark District. It contains the graves of more than 35,000 veterans and their family members, dating back to the 1846 war with Mexico.

We should meet at 10:00 am by the flag pole on the Presidio grounds. The Ceremony will be over at noon and maybe we all could have lunch together.

I plan to be there, Steve Johnson and John Gee have indicted they will be there. It would be nice if we could have several others from the Camp. Uniforms not necessary.
